The Covenant Centre for Development (CCD) – A brief history

From the desk of the Secretary

Greetings!

This is the third decade of the existence of CCD. As we walk down the memory lane, we realize the importance of looking back at the path we have tread. The path we have walked has evolved organically and has been shaped by the context, local, regional, national and global forces.

The first decade of CCD, during the early 1990s, was spent addressing issues related to migration and evils attached to it through establishment of grassroots institutions, notably women's self help groups and their federations followed by micro finance and Community Based Rural Enterprises using Local Resources and Traditional Skills (LRTS).

The second decade during early 2000s was spent on establishment of social enterprises using regional resource during lean agricultural seasons. This was the period during which the *Gram Mooligai Company Ltd.*, was constituted, followed by several others in the areas of energy and foods.

The third decade, since 2010 was spent on scaling up the activities by forming Farmer Producer Companies (FPC) involving Primary Producer as Groups (PPGs) for collective operations and market linkages with major corporates.

Looking forward into the future is always fraught with uncertainty. Yet, a vision, however crude, for the next decade is essential. Unlike in the past, changes are rapid, requiring a different approach and strategy. Pro-active action in all areas is required. Scale in terms of targeted participant communities, area of operations, area of interventions, volume and cost is vital. The importance of collaboration and networking is likely to grow, calling for major shifts in the manner in which operations are carried out.

This is also the time for transferring the knowledge, expertise and varied experience of the last three decades for creation of the next generation of youngsters. CCD should now focus more on the upcoming generation notably children, with a well planned strategy for transfer of this valuable knowledge, that will help them be prepared for meeting major challenges and unforeseen circumstances of the future. Dealing with environmental degradation, increased need for conservation at a time when there is rapid erosion of socio-cultural values related to nature, is indeed going to be an uphill task. We realize the importance of inculcating values among the younger generation as an important task ahead of us.

CCD is obliged to the massive support provided by the women self help groups, farmers, other rural stakeholders including traders in this robust work over the past three decades. The work of CCD would not have been possible without the active and whole hearted support of a large number of donors, national and state agencies, foundations, corporate and individual donors, too numerous to list. With the continued and growing support of the Board, Staffs, Community, Government and Private sector, CCD hopes to continue to enlighten thousands of lives in future as well.

1.1 Programme Area: Conservation

1.1 Vaigai Flora Botanical Garden (VFBG)

CCD undertook a review of the Ethno-Medicinal Forest (EMF), Herbarium, Seed and Raw Drug (HSRD) Museum, Decentralized Conservation Nursery (DCN), Conservation Education Programs (CEP), Demo Gardens (DG) and various components located at the Sevaiyoor Campus. It was decided that these components would be recast as the Vaigai Flora Botanical Garden (VFBG).

Since Medicinal Plants Conservation Park (MPCP) was established under the FRLHT sponsored MPC and RLHT program from 1995. Out of its 25 years of existence till 5 years before it has survived with less than 20% of mortality but due to severe and chronic drought current year, we have lost around 60% of the plants, hence the decision of MPCP into VFBG. The only significant change in the whole of effort is to irrigate the plants unlike in the last 25 years it has been trained without external watering.

Whereas the whole infrastructure EMF, HSRD, DCN, CEP and DG will continue under the VFBG with more focus on improved trails and signage. Organized self explaining trails and package of programs depending on the user groups will be tailor made for their effective experiences. Improving the existing logistics support and infrastructure facilities will be made available for effective use of the available resources and experiences.

As part of the NaturYuva Project, CCD undertook that task of conservation and evaluation of some traditional varieties of Moringa. Cuttings of Moringa collected from different parts of dry regions in the district have been planted and conserved in a plot at Sevaiyoor for commercialization of its medicinal value.

Dabur's bark species of 10 tree species in Tamilnadu and 5 species in Chhattisgarh are under rapid plantations in farmers' field as an agro-forestry both in Tamilnadu and Chhattisgarh. Similarly one of the neuctraceutical from Vijayawada called Laila Neutraceutical were also experimented with wild collection of moringa leaves from the forest areas as an organic material for their EU requirements. Wild collections of forest species from the respective forest development corporations in Chhattisgarh, Madhya Pradesh and Orissa continued for Dabur.

Efforts are being made to replant some of the uprooted plants affected by Gaja Cyclone in Nagapattinam districts through NOFPCL were prepared with both Dabur and Isha Outreach partnership is under the pipeline for the execution in the coming season. Exploration of Chalmogra tree species cultivation in Natham and setting up of an oil-extraction plant at Sevaiyoor were also prioritized.

Under the agro-biodiversity conservation the year, black and red rice varieties collected from Sooranam in Sivagangai District was multiplied in the Sevaiyoor farm. The multiplied seeds were distributed to farmers in Uchipuli, Ramanathapuram district, where these varieties were used to be cultivated earlier. In the same manner minor millets were collected from Thirumangalam from Madurai and Abhiramam from Ramanathapuram were also replicated in Uchipuli for maximising the proposed traditional paddy and minor millets processing facilities under IFAD projects.

1.2 Analysis of Value Chains of Medicinal Plant Trade in Tamil Nadu

The GIZ, New Delhi provided support to CCD to undertake a study titled, "Analysis of Value Chains of Medicinal Plants Trade in Tamil Nadu for the effective implementation of the Access and Benefit Sharing (ABS) provisions of the Biological Diversity Act 2002". Medicinal plants is the focus of the study, considering the fact that it has a sizeable biological diversity and is important in biodiversity trade, while also supporting livelihoods of the poorest people.

As part of the study field surveysand investigations carried out on selected medicinal plant bio-resources collected/traded from selected locations in Tamilnadu. The CCD team surveyed 81 villages, spread across 36 blocks of 10 districts in Tamilnadu. 806 gatherers surveyed (of them, 71% are women), 80 medicinal plants farmers, 40 traditional healers (called "vaidyars"), 72 traders, 38 nurseries, 16 processing industries, 8 exporters and 8 researchers are consulted, totalling 1212 persons. These are locations that are rich in biodiversity, high in poverty and where trading in medicinal plants is important income activity villagers.

The roles of critical actors (gatherers, procurement agents, local cultivators, petty and major traders, processors, companies and exporters) were studied in the light of Access and Benefit Sharing (ABS) provisions.

Information on important locations in Tamil Nadu linked to medicinal plants bio-resource trade (villages, taluks, districts) that can possibly be taken up as priority areas for establishing and operationalizing Biodiversity Management Committees (BMCs) and implementing ABS provisions.

Some important highlights of the study:

Gatherers usually collect 200 kg herbs on average, mostly from 4-5 species, earning about Rs. 10,000/- (ten thousand) each/ season, constituting about 20% of their annual income, critical to meet the poverty gap. Price spread is low- out 30-40% for most species. The herbs trade value per village is about Rs. 1 lakh/ year and per Gram Panchayat- it can be Rs. 3-5 lakh/ year.

At the taluk level, 20-25 active medicinal plants traders, have a turnover of about Rs. 25 lakh/year.

ABS can be implemented and the study expressed that charging or levying a fee at GP/village BMC level would encourage villagers in raising awareness about biodiversity and its sustainable management. Their ABS certificate could possibly be used at higher levels like district or state check post like way bill that trucks could carry and present when required.

The CCD Report has suggested modifications in the PBR format to include commodity price, to enable fee (2%) computation on the spot, and payment to BMC as an agent of the SBB.

1.2 Programme Area: Rural Livelihoods and Community Based Enterprises (CBEs)

The programme area covers two dimensions of the work: Livelihood Projects supported by various agencies of the state and donors, Community Based Enterprises under the Farmer Producer Companies that were established by CCD, which are now fully functional, contributing to the rural livelihoods.

1.2.1 IFAD (international Fund for Agricultural Development)

The International Fund for Agricultural Development (IFAD) supported a series of projectsthat is currently in its seventh year of operations. The role of CCD is to extend assistance in four areas.

- o Skill Development through training in technologies to improve yield and reduce farming cost
- o **Organizing and Institutional Building** through institutionalising of farmers in groups, federations and producer companies
- o Finance Linkages through banks and government schemes and
- Supply Chain and Marketing by connecting with corporates seeking raw material sales on routine basis.

IFAD Assisted PTSLP Sub Sector Extension of Mango based Micro Enterprise Development through Primary Producer Groups (PPGs) in Nagapattinam District

The project supports 3000 mango, medicinal herbs and vegetable farmers in Nagapattinam district and 1000 farmers cultivating traditional paddy and minor millets in Ramanathapuram district.

Activities carried out during this reporting period:

Training / Capacity Building imparted to members of the PPG to enhance their knowledge and skill

 Training programmes arranged covering enhancement of member skill, leadership, accounts and EDP.

Technical training

Trainings on technical aspects on mango cultivation namely, for improving productivity and reducing the cost of cultivation, value addition and marketing.

Conduct of Market Study

 Market study initiated covering producers, commission agents, traders, retail outlets, sandies and wholesale markets.

Machinery & Infrastructure facility

- 1) Supported the NOFPCL in obtaining 3 quotations from the vendors on machinery and accessories for the pulping machinery and accessories
- 2) Coordinated for the Civil Construction plan and approval obtained for factory layout

Mobilization of Skilled people among the Federation

Interested and inclined educated youngsters will be recruited from the federation member families to be trained on the different functions of the production line

Mobilization of Working Capital

Apart from the working capital advance provided by the buyers, banks and financial institutions have been identified for taking care of additional working capital requirements for the packing materials and optimization of the facility

Market Tie-ups

Forward linkages will be established for marketing the produce from the plant. Existing goodwill will be leveraged for confirming the orders from the buyers.

Note- the mango variety used here is wild, sour, cheap type, not the sweet, costly, table variety.

The following industries are purchasing raw mango fruits promoted by CCD institutions for the last few years: Nadukkara Agro Processing Ltd., Ernakukam, Kerala, Ruby Foods, Madurai. Over 1,500 ton of Mango fruit was sold to the above industries over the last few years, through groups/federation, directly benefiting the farmers.

Under the guidance of Indian Institute of Food Processing Technology (www.iifpt.edu.in), Thanjavur, a Centre of Excellence, a multi-commodity fruit and vegetable processing factory was established by CCD at Kameshwaram with a 40 tpd (ton per day) capacity this year. It was trial run during the summer of 2019. The facility cost a sum of Rs. 7 crores for installation with the cost contribution:

- o Farmers- 35 lakh (2 acre) (5%)
- o Machinery- 35 lakh (5%)
- o Building- Rs. 3.5 crore (50%)
- O Working capital- Rs. 2.8 crore (40%)

90% of the contribution was by IFAD and 10% by the community and CCD. The Nagpattinam Organic Farmer Company Limited (NOFPCL) promoted this effort.

IFAD Assisted PTSLP for Minor Millets and Traditional Rice for Production and Value Addition at Ramanathapuram

This is separate component for promoting traditional paddy and millets. For ensuring value addition to primary produce, machinery was installed at Ucchipuli in Ramanathapuram with a capacity of 2 ton/hour and would benefit 3,000 farmers in the location. A work shed has been constructed for housing the machinery on a land leased for the purpose. Earth 360, a community based social enterprise at Ananthapur, Andhra Pradesh was the technical consultant to the project. Traditional rice sold include red and brown, while bran sold for oil extraction. The black rice is sold at Rs. 68/- kg- while its paddy price is Rs. 35/- kg, grain yield is 65%. Scented paddy "Samba" is bought at Rs. 23/- kg while rice is sold at Rs. 45/- kg.

This is the second year of the project and buyers include: Surabhi organic- paddy https://www.tradeindia.com/Seller-9231954-SURABHI-ORGANICS/and 24 mantra- millets-https://www.24mantra.com/ (its a organic shop chain in metros, starting from Hyderabad but rapidly growing in Bangalore, Chennai etc.)

Production, Value Addition & Marketing of Semi – Arid Farm Produces by Partnership involving Farmer Producer Companies as Primary Producers, Corporate as Buyers, CCD as Service providers and PTSLP as Promoter. Adding value to Minor Millets, Raw / Parboiled Rice and Flakes from Traditional paddy varieties at Ramnathapuram District

- 1) Identified 68 CRP (Community Resource Person) for PPG formation
- 2) Baseline Data Collection and analysis completed for 1304 households across 12 panchayats
- 3) Primary producers identified 1154
- 4) Savings collection Rs.3.20 lakhs from the 68 PPGs across 4 clusters
- 5) Successfully merged the PPGs to the Abhiramam Traditional Farmer Producer Co Ltd with 6 representatives as Directors of the Company
- 6) Statutory Compliance adhered and necessary changes in the MoA and AoA were incorporated
- 7) Capacity building on leadership was imparted to 724 members (with 52 training programmes). In Value addition and Marketing 65 members participated (with 6 training programmes in Communication and 4 in Group Dynamics)
- 8) Shortlisted the vendors for value addition machinery for both minor millets and traditional rice have been identified
- 9) Working Capital needs discussion were held with the mainstream financial institutions and social finance ventures with M/s Ananya and M/ Samunnati
- Exposure visits and training on medicinal plant kitchen herbal gardens were provided to the PPG leaders

1.2.2 NABARD PROJECT: Producer Organisation Promoting Institution (POPI)

CCD is guiding and handholding 12 NGOs in different districts of Tamil Nadu to improve farmer income through direct or collective marketing to the industry, with some value addition where possible. In addition, 24 Farmer Producer Companies (FPC) registered under the Companies Act 1956 are being promoted with cumulative membership of 24,000 farmer families. Assistance is being extended to organizations and federations for running the business, marketing and compliance of the Company affairs. Compliance support was provided to the FPOs for obtaining the GST, FSSAI licensing and annual audit. Project Monitoring Committee (PMC) meetings were organized for the FPOs who were yet to receive the allocated funds. Support was provided for each of the FPO to prepare business plan for working capital support from the mainstream Banks and SFAC support from NABARD.

1.3.3 **DABUR - CSR**

<u>Title:</u> "Promotion of High Density short term (HDST) Program as agro-forestry model for selected medicinal species"

Dabur India Pvt Ltd. has engaged CCD in conservation and sustainable use of threatened medicinal plants that involvebark extraction. The species targeted for the programmeare: *Shyonak-Oroxylumindicum*, *Patala-Stereospermumpersonnatum*, *Bael-Aegle marmelos*. These are part of the Dasmula (ten roots) group of Ayurvedic herbs used in the preparation of tonics such as Chyavanprash. Total of 30,000 saplings of these rare medicinal herbs species were raised and planted at Nattam cluster of CCD.

The project has major work share in Chhattisgarh state where farmers are encouraged to grow these species in Dhamatari and Korba districts.

Nursery

This programme was implemented in the Dhamtari, Bilaspur and Korba region of Chhattisgarh state. Four species were identified jointly by JWCT in consultation with Dabur India Limited and CCDfor inclusion under the project.

Species for High density short term plantation/agro-forestry in farmers' field

- 1. Bael (Aegle marmelos)
- 2. Gambhari (*Gmelina arborea*)
- 2. Padal (Stereospermumsuaveolens) 4. Syonak (Oroxylumindicum)

Nurseries of selected plant species were established during the tenure of the project. A total of 25,000 saplings per species (total 100,000) was raised during the year 2018-19. CCD implemented the programme through existing village institutions like Self Help Groups (SHGs)/ Biodiversity Management Committees and Village Organizations (VOs) through the following key activities:

- Collection of Quality planting material for the nursery/ sapling production.
- Production of elite saplings for the above species at two selected sites.
- Identification and selection of beneficiary in the project areas and ensuring planting material/sapling supply to them.
- Distribution of saplings and technical support to the households for planting in HDST programme designed by mutual concerns of CCD and JWCT.

- Sapling distribution of selected species of fruits, vegetables, and other regional crops under the agro-forestry model. Plantation assurance and technical support till the gestation period of the selected species.
- The gestation period of the species will be 2 yr, 1.5 yr and 6 month for Bael, Padal and Syonak/ Gambhar respectively. CCD will also ensure the beneficiary support for the other plantation requirement under agro-forestry model like fruit, vegetable and any other suitable regional crops.
- Training/ capacity building for nursery raising, young root production and sustainable forest
 collection through 1-2 days workshops shall be organized in all project sites every year during
 respective seasons.

Dabur CSR Sustainable Project (CCD South)

Under the Dabur CSR projects in Tamilnadu, we are working in two locations, one is the semi-arid region popularly known as Ramnad plains, administratively part of Madurai, Sivaganga, Ramanathapuram, Virudhunagar, Tirunelveli and Tuticorin districts; another in the fragile Western Ghats of Theni and Dindigul districts.

The first geography which is the Ramnad plains is known for its drought and large number of acres under waste and fallow lands. Hence, huge chunk of traditional gatherers and socially oppressed communities collect medicinal plants from community lands and market them to local traders. Similarly, the second region is historically inhabited by traditional medicinal plant gatherer communities that solely depend on medicinal plant collection round the year. Moreover, they are totally dependent on local intermediaries for sale of their produce.

Currently, both the regional gatherers directly bill to Dabur through their social enterprise Gram Mooligai Co Ltd, They are gaining 50% additional income which has been achieved through reduction in the number of intermediaries in the supply chain. Instead of routing through five different intermediaries in the supply chain, they have completely transformed and shortened the chain. Thye have also shifted from destructive harvest methods to sustainable collection and quality production at the source achieved through Dabur CSR fund on training and infrastructure. In the process not only corporate but also the local traditional healers and processors are getting quality produce that ultimately benefits consumers.

The two models evolved out of Dabur Partnership with CCD in its initial intervention near the Tirunelveli wind mill areas. Raising crops or trees under the wind mills became impossible. Hence as a win-win situation for farmers who loses the land by sale to Suzlon and Suzlon as Windmill Firm wants to secure its infrastructure from theft and fire. GMCL has made use of the opportunity to motivate farmers to grow the seasonal herbs particularly *Boerhiva diffusa* root when demand peaks and there is scarcity from wild collections.

Project Interventions by Dabur

- <u>Change in crop pattern</u>: Since the gatherers knew the Dabur demand well in advance, they were able to introduce seasonal herb as intercrops and shrubs and climbers as hedge cropping, bark tree species were planted in the boundaries as agro forestry model which is actually generating not only substitute income but also generating seasonal employment.
- QPM support: Since the momentum were created among the small and marginal farmers for inter cropping seasonal herbs such as Tulasi, Kalmegh, Vinca, Senna and Macoy, round the year quality seed production and high germination seeds are supplied to farmers. Bark tree

species such as Azadirachta indica (Neem), Ziziphus mauritiana (Elanthai), Albizia lebbeck (Vagai), Murraya koenigii (Karuvellai) and Strychnos nux-vomica (Etti). Similarly oil seeds like Azadirachta indica (Neem), Pongamia pinnata (Karanj), Ricinus communis (Castor) and Madhuca / Mahua longifolia (Illuppai) have been distributed to farmers for introducing them around boundaries for generating a perennial income.

- <u>Capacity building</u>: There is a calendar of training primary producers at the beginning of every season. The youth and young people are also being trained as bare foot botanists for monitoring and guiding the primary producers on a reguar basis. Since, the gatherers are trained on sustainable collection and production at source, and provided with the necessary and logistics, and de-centralized warehouse facilities, gatherers are able to provide assured supply of authentic raw drugs on time at a reasonable cost.
- Areas/acres under cultivation: Boerhavia diffusa, Jivanthi, Gymnema sylvstre, Plumbago were cultivated around 5 acre each. 5000 saplings of bark and oil tree species were planted around the boundaries of the small and marginal farmers

Impact of the project

- <u>Social condition</u>: Earlier gatherers were solely depending on intermediaries who treated them badly. In fact, gathering of medicinal plants as an activity created a stigma among young and middle aged women, only the elders were involved in the profession, now due to their share and stake in Gram Mooligai they are proud of being part of a company which is ultimately supplying to reputed organization like Dabur. Several young girls and boys were entering into this profession with pride.
- <u>Economic condition</u>: Since the primary producers are by passing through 5 different intermediaries such as procurement agent, commission agency, traders, etc. they are getting minimum 50% hike for their produce. The presence of decentralized warehouses and logistics for quality production has reduced pressure on gatherers on distress sale. Materials are aggregated at the source itself, they are saved from travelling long distance and risks associated with travel.
- New introduction of crop: There are three sets of different groups of species have been introduced from time to time based on the need and potential as intercrops: bark and oil trees species that can be raised on boundaries; shrubs and climbers in between crops as agro forestry models.
- New market intervention: Recent development with Dabur Bio Resource Division for motivating the traditional gathering communities to collect the seeds of Chalmogra, Mahua, Pongamia, Neem etc. for supplying as oil than forwarding as seeds. This process motivated gatherers to plant more trees, since it will generate employment during the lean collection season. In the process they are also getting more benefit than employment. The same similar sort of process is expected for other raw drugs to supply as semi processed powder form. Honey procurement and processing also in line with Dabur supply.
- Beneficiaries in the windmill region have moved to supply semi processed materials to the neighbouring Kerala markets, such as traditional ayurvedic houses, retail raw drug sale outlets at weekly mandies etc.

1.3.4 USHA MARTIN - Sevaiyur, Sriperambudur, Lakshwadeep (Agatti) and Nagapattinam

Usha Martin Sewing Machine Company is supporting girls belonging to economically weaker sections in training them in sewing. This activity was promoted through CCD in Madurai for the last ten years. Recently, the work was extended to Sriperumbadur near Chennai to Agatti in LakshdweepIslands.

Average Team of 15 women members were provided with the Usha Sewing Machine and empowered with the stitching of various garments. These women will further provide to 15 to 20 women in their respective villages. This skill will enable the women to supplement the income of the family.

Bulk orders for stitching uniforms and garments are passed on to the members who have undergone training so that their livelihoods are sustained round the year.

1.3.5 **EXIM BANK**

Aharam weavers FPC was provided with special pedal weaving machines of Gujarat. The company has sales of Rs. 50 lakh/ year, benefitting 40 artisans, and 30 support staff, besides fair price to many more cotton farmers.

Used fishing nets of Nylon are also made in to bags as inventive eco-friendly activity.

A brief history of CCD

The Covenant Centre for Development (CCD) is a Madurai based national level non-governmental organization (NGO) committed to the cause of sustainable development. It was established in 1988, with the primary objective of organizing informal sector farm labourers into thrift and self-help groups, strengthen the culture of savings at the household and group levels and to enhance access to institutional credit. Over a period, this work extended to the area of medicinal plants, a natural resource that made a significant contribution to off season rural livelihoods in several of the semi-arid districts of Tamil Nadu.

During 1992-2002, CCD partnered in the Honeybee Network and was actively involved in scouting, documenting and validating close to 6000 innovations of unaided inventors and traditional grassroots traditional knowledge holders in the southern districts of Tamil Nadu, with a specific focus on food and medicine.

The COMPAS Asia Project, of which CCD was a partner, involved documentation and validation of local health traditions in 13 panchayats in Narikudi Block of Tiruchuzhi Taluk in Viruthunagar District.

DANIDA supported a series of project for documentation of medicinal plant trade in Tamil Nadu, Kerala and Karnataka during 1999, based on which the Gram Mooligai (Village Herbs) Company Limited (GMCL) was established in 2000, and Aharam Traditional Crop Producer Co. Ltd. (ATCPCL) in 2004.

In 2002 HIVOS supported a project to support the study of medicinal plants in Madhya Pradesh and Odisha.

In 2004 Oxfam supported a major project covering 9 states including Andhra Pradesh, Pondy, Chhattisgargh and Maharashtra. The outputs were used for the establishment of the MAPSCON Network in 2006.

In 2009-2012 Christian Aid supported a project to undertake studies in Rajasthan, Gujarat and UP.

During 2009-2012 CCD and GMCL moved to other states to upscale the work related to medicinal plants and gradually ventured into the organic rain-fed agricultural crops as well. Farmers were mobilized into groups and group certification obtained. As on date, a total of 36 Primary Producer Groups (PPGs)/ Farmer Producer Companies (FPC) on a Community-Based Enterprise (CBE) mode dealing with medicinal plants, rain-fed agricultural crops and other livelihoods like mango pulp and coir rope making have been established with the support and guidance of NABARD. The CBEs also provide services to member groups namely, input supplies, credit and insurance. At the district-level, these FPCs work has established a Confederation of FPCs, which has started the distribution of semi-processed medicinal plant materials to several Ayurvedic Companies. As on date, the organization works with about 5000 households across 200 villages in the districts of Madurai, Dindigul, Theni and Thoothukudi.

GMCL is the first Indian company to pay Access and Benefit Sharing fee to the Madhya Pradesh State Biodiversity Board (MPSBB), which amounted to 2% of its annual raw drugs purchase value. Recognizing the efforts GMCL was awarded the first Biodiversity Award 2017 constituted jointly by the UNDP and Government of India.
