VETERANS CARBON HOLDINGS SET TO ISSUE FIRST BCARBON-VERIFIED SOIL CARBON CREDITS; CREDITS TO BE MINTED ON DOVU'S HEDERA BLOCKCHAIN FOR GLOBAL SALE

Fargo, ND: Veterans Carbon Holdings, Inc. (VCH) announced today that its first portfolio of science-based soil carbon credits, generated from farmers and landowners across North Dakota and Minnesota, is now under final review by BCarbon, with issuance expected by late December. Upon issuance, all verified credits will be minted, tracked, and made available for purchase on DOVU's blockchain platform, powered by Hedera Guardian. This milestone represents one of the first large-scale integrations of BCarbon-verified soil carbon credits into a fully transparent, digitally traceable blockchain marketplace.

Strengthened Validation to Meet International Standards

During the review process, which began in mid-November, VCH completed all required documentation for EU, UK, Asian, and North American markets. Enhancements were made to align with the highest global standards for environmental integrity, including:

- Good Stewardship & Land Management protocols
- Additionality
- Permanence & long-term land use commitment
- Carbon neutrality for each participating farmer and landowner
- Full transparency in measurement, modeling, and quantification methods
- Immutable tracking, retiring, and auditing of credits
- Biodiversity metrics compliant with UK market expectations

Once credits are issued and transferred to DOVU, VCH will stand alongside BCarbon (Rice University) and DOVU as pioneers in the first wave of quantifiable, verifiable, blockchain-tracked agricultural soil carbon credits. Market demand is already emerging from buyers in the UK, Asia, Canada, and additional regions seeking high-integrity offsets.
