DOG TREADMILL SUBSCRIPTION AGREEMENT

This Dog Treadmill Subscription Agreement (the "Agreement") is entered into between _____ (the "Customer") and DANX To The Rescue (the "Company"), effective on the date of the Customer's signature below.

SUBSCRIPTION TERMS AND CONDITIONS

PACKAGE B SUBSCRIPTION: By purchasing Package B subscription, the Customer will receive the following benefits: a. A 25% discount on dog daycare services, subject to availability. b. A 25% discount on dog boarding services, subject to availability. c. Three weekly appointments to utilize a 30-minute treadmill session for their dog(s). d. A 25% discount on a la carte grooming services. e. The opportunity to stay with their dog(s) during the treadmill sessions. f. Free 3-hour playtime for their dog(s) either before or after the treadmill session, as determined by the dog's activity level. g. One free 45-minute group dog training class per month on specific topics such as jumping, tricks, walking on a leash, and others, subject to the dog's qualification for such classes.

PAYMENT TERMS: The Customer agrees to pay the monthly subscription fee for Package B, as disclosed at the time of sign up, and authorizes the Company to charge their provided payment method for such subscription fee and any additional charges for services utilized. All subscription fees are non-refundable.

RESERVATION OF SERVICES: All services offered under the Package B subscription, including daycare, boarding, treadmill sessions, and group training classes, are subject to availability. Customers must reserve their desired slots in advance, and the Company cannot guarantee availability for any specific date or time.

CANCELLATION POLICY: Customers may cancel their subscription with a 30 days' written notice. Subscription fees for the current month will not be refunded, and the Customer will continue to have access to their subscription benefits until the end of the current billing period.

CHANGE IN TERMS: The Company reserves the right to change the terms of this Agreement, including pricing and included benefits, at any time. The Customer will be notified of any such changes and continued use of the subscription services will constitute acceptance of the changes.

GENERAL TERMS AND CONDITIONS

LIABILITY: The Customer has read and agrees to the terms of the Dog

Treadmill Use Agreement and Waiver of Liability and understands that it applies to all services provided under the Package B subscription.

OWNERSHIP AND DECISION-MAKING AUTHORITY: The Customer attests that they are the legal owner of the dog(s) they are signing up for the service, or if not, they have the requisite authority to make decisions pertaining to the health and exercise regime of the dog(s). The Customer agrees that all the information provided to the Company is accurate and complete to the best of their knowledge.

PHOTOGRAPHY, VIDEO, AND SOCIAL MEDIA: The Customer grants DANX To The Rescue permission to use any photographs or video footage of their dog(s) using the treadmill for any lawful promotional, informational purpose, or for sharing on social media platforms.
