

**COLORADO RIVER FAIR
RV PARKING LOT
RULES & REGULATIONS \$125**

The Colorado River Fair Management reserves the right to refuse service and modify RV Parking rules and regulations.

Applications are due no later than February 15, at which point the Administration will no longer have anything to do with the RV Parking lot, other than to settle disputes that may arrive. The parking lot host will coordinate with you as to when parking can commence. Typically parking starts the Monday before Fair.

YOU MUST HAVE YOUR RV PERMIT AND VEHICLE PERMIT WITH YOU IN ORDER TO PARK.

Security will be on site to enforce rules and regulations of the Colorado River Fairgrounds RV parking lots. Anyone found in violation of these rules will have his or her privileges revoked and will be removed from the RV lot. The CEO will have the final decision in all disputes. **Gates open at 6 am. and closes at 10 pm. sharp.**

ABSOLUTELY NO UNREGISTERED GUEST WILL BE ALLOWED IN THE RV PARKING LOTS.

Any person riding in a vehicle enter into Lot #1 must be wearing a 2020 wristband and be on the RV parking Vehicle Application, listed under occupants, or they won't be permitted to enter. All vehicles must display the proper permit at all times to re-enter the lot. Speed limit is 5 MPH – Drivers must obey and operate their vehicles in accordance with posted regulations and applicable Federal, State and local laws. Dogs/cats of any breed are not permitted on grounds. Service dogs are welcome with the proper paper work.

All personal equipment must be kept neat and tidy within your assigned space. RV sites must be kept clean for the enjoyment of all guests. **Alcoholic beverages are NOT allowed outside of your RV space.** Drugs, weapons, fighting, reckless driving, and speeding will be grounds for revocation of privileges. Any vehicles parked in the RV lots without the proper permits will be towed at the owner's expense.

NO LOUD MUSIC AT ANYTIME: Quiet hours are between 10:00 p.m. and 6:00 a.m. No loud talking or generators. Please be considerate of others. Disorderly conduct will not be tolerated.

By signing this RV Park Vehicle Registration Form, I hereby acknowledge that I have received and read the Rules and Regulations for the Colorado River Fair RV Park and accept responsibility for all occupants in my assigned RV space, Violation of said Rules and Regulations will result in the immediate removal from the Colorado River Fairgrounds RV Park and any other action deemed appropriate by Fair Management.
