

- A. The Grant Parish Police Jury hereby divides and creates new precincts to be used in its redistricting plan to be first implemented for all purposes related to the regularly scheduled elections Grant Parish for qualifying for elections in the Fall of 2022.
- B. These precincts are hereby described below and specifically depicted on maps and electronic shapefiles provided to the Secretary of State and the Grant Parish Registrar of Voters for their implementation
- C. The precincts listed in Part C are described specifically in Part D through Part N

Current Precinct 2-1 is hereby divided to create Precincts 2-1, 2-1A and 3-4.

Current Precinct 2-2 is hereby divided to create Precincts 2-2 and 1-5.

Current Precinct 4-2 is divided to create Precincts 4-2 and 5-4

Current Precinct 5-3 is divided to create Precincts 5-3 and 2-4

Current Precinct 6-1 is divided to create Precincts 6-1 and 7-5

Current Precinct 6-3 is divided to create Precincts 6-3 and 7-6

Current Precinct 7-2 is divided to create Precincts 7-2 and 2-6

Current Precinct 7-3 is divided to create Precincts 7-3 and 2-7

## D. Current Precinct 2-1 is hereby divided to create Precincts 2-1, 2-1A and 3-4.

Polling Location: Precincts 2-1, 2-1A and 3-4 shall have a consolidated polling location at the current polling location of Precinct 2-1

#### **Precinct 2-1A**

Beginning at the intersection of the Natchitoches-Grant Parish boundary and Richardson Road and it's extension, then east on Richardson Rd to its intersection with a railway, then south following the railway to its intersection with Highway 158, then south on Hwy 158 to its intersection with Foulk St, then west on Foulk St to its intersection with East 6<sup>th</sup> St, then north on East 6<sup>th</sup> St to its intersection with Walnut St, then west on Walnut St to its intersection with West 6<sup>th</sup> St, then south on West 6<sup>th</sup> St to its intersection with Mary St, then east on Mary St to its intersection with East 6<sup>th</sup> St, then south on East 6<sup>th</sup> St to its intersection with Louise St, then west on Louise St to its intersection with an unnamed street 190 feet north of Mary St., then west on this street to its intersection with Louise St, then west on Louise St to its intersection with Louise St, then west and south on Mary St, becoming 4<sup>th</sup> St, to its intersection with Louise St, then west on Louise St to its intersection with 3<sup>rd</sup> St Extension, then northwest on 3<sup>rd</sup> St extension to the parish boundary, then north on the parish boundary to the point of beginning.

#### **Precinct 3-4**

Beginning at the intersection of Highway 158 and Foulk St, then west on Foulk St to its intersection with East 6<sup>th</sup> St, then north on East 6<sup>th</sup> St to its intersection with Walnut St, then west on Walnut St to its intersection with West 6<sup>th</sup> St, then south on West 6<sup>th</sup> St to its intersection with East 6<sup>th</sup> St, then south on East 6<sup>th</sup> St to its intersection with Louise St, then west on Louise St to its intersection with East 6<sup>th</sup> St, then south on East 6<sup>th</sup> St to its intersection with North St, then west on North St to its intersection with 5<sup>th</sup> St, then north on 5<sup>th</sup> St to its intersection with an unnamed street 190 feet north of Mary St., then west on this street to its intersection with Mary St, then west and south on Mary St, becoming 4<sup>th</sup> St, to its intersection with Louise St, then west on Louise St to its intersection with 2<sup>nd</sup> St, then south on 2<sup>nd</sup> St to its intersection with Main St (Hwy 8), then east on Main St to its intersection with 3<sup>rd</sup> St, then south on 3<sup>rd</sup> St to its intersection with Cypress St, then east on Cypress St to its intersection with 8<sup>th</sup> St, then north on 8<sup>th</sup> St to its intersection with Hwy 8, then east on Hwy 8 to its intersection with Hwy 158, then north on Hwy 158 to the point of beginning.

## Precinct 2-1

Beginning at the intersection of the Natchitoches-Grant Parish boundary and an unnamed tributary located at approximately (-92.796808, 31.595845), then northeast on the tributary to its intersection with a powerline located at approximately (-92.791540, 31.598693), then southeast on the powerline to its intersection with Richardson Rd, then west on Richardson Road and its extension to the parish boundary, then north on the parish boundary to the point of beginning.

# E. Current Precinct 2-2 is hereby divided to create Precincts 2-2 and 1-5.

Polling Location: Precincts 2-2 and 1-5 shall have a consolidated polling location at the current polling location of Precinct 2-2

## Precinct 1-5

Beginning at the intersection of an unnamed tributary and a powerline, the intersection located at approximately (-92.791568, 31.598719), then northeast on the tributary to its intersection with boundary of Lake Nantoches, then easterly along the lake boundary to its intersection with an unnamed road at approximately (-92.778221, 31.605548), the south on the road to its intersection with Hwy 1240, then northeast and north on Hwy 1240 to its intersection with Baudry Rd, then east on Baudry Rd for 770 feet to its intersection with a powerline, then southeast on the powerline to its intersection with

Patch Leg Rd, then south on Patch Leg Rd to its intersection with Bayou Grappe, then southerly on Bayou Grappe to its intersection with a unnamed canal located approximately at (-92.750602, 31.563658), the west on the canal to its intersection with Richardson Rd, then south on Richardson Rd to its intersection with a powerline located approximately at (-92.747193, 31.557648), then northwest on the powerline to the point of beginning.

#### **Precinct 2-2**

Beginning at the intersection of Hwy 1240, and Baudry Rd, then east on Baudry Rd for 770 feet to its intersection with a powerline, then southeast on the powerline to its intersection with Patch Leg Rd, then south on Patch Leg Rd to its intersection with Bayou Grappe, then southerly on Bayou Grappe to its intersection with a unnamed canal located approximately at (-92.750602, 31.563658), the west on the canal to its intersection with Richardson Rd, then south on Richardson Rd to its intersection with a powerline located approximately at (-92.747193, 31.557648), then southeast on the powerline to its intersection with Hwy 158, then northeast on Hwy 158 to its intersection with US Hwy 71, then northerly on US Hwy 71 to its intersection with Hwy 471, then north on Hwy 471 to its intersection with a powerline located approximately at (-92.723716, 31.578007), then southeast on the powerline to its intersection with Lemoine Cutoff Rd. then south on Lemoine Cutoff Rd to its intersection with Valentine Bayou, then northeast on the bayou to its intersection with Lake Latt, then north on the centerline of the Lake to its intersection with Hwy 122, then west on the highway to its intersection with Parasol Rd, then south on Parasol Rd to its intersection with New Bridge Rd, then west on New Bridge Rd to its intersection with Big Hill Rd, then west on Big Hill Rd to its intersection with Hwy 471, then south on the highway to its intersection with Dartigo Creek, then south and west on the creek to its intersection with La Pet Creek, then west on the creek to its intersection with Hwy 1240, then south on Hwy 1240 to the point of beginning.

# F. Current Precinct 4-2 is divided to create Precincts 4-2 and 5-4

Polling Location: Precincts 4-2 and 5-4 shall have a consolidated polling location at the current polling location of Precinct 4-2

## Precinct 5-4

Beginning at the intersection of Parish Rd 27 and a canal located approximately at (-92.501797, 31.443351), then east on the canal to its intersection with US Hwy 167, then south on the highway to its intersection with Parish Road 27, then northerly on Parish Road 27 to the point of beginning.

# **Precinct 4-2**

Beginning at the intersection of Parish Rd 27 and a canal located approximately at (-92.501797, 31.443351), then east on the canal to its intersection with US Hwy 167, then south on the highway to its intersection with the Grant-Rapides Parish boundary, then east on the boundary to its intersection with a railway located approximately at (-92.450172, 31.428533), then north on the railway to its intersection with Hansford Rd, then west on Hansford Rd for .40 miles to its intersection with an unnamed creek, then south and west on the creek to its intersection with US Hwy 167, then south on the highway to its intersection with Rogers Dr, the west on Rodgers Dr to its intersection with Paul St, then south on Paul St to its intersection with Brenda St, then west on Brenda St to its intersection with Morris Rd, then north on Morris Rd to its intersection with Hwy 1241, the west on the highway to its intersection with Parish Road 27, then south on Parish Road 27 to the point of beginning.

# G. Current Precinct 5-3 is divided to create Precincts 5-3 and 2-4

Polling Location: Precincts 5-3 and 2-4 shall have a consolidated polling location at the current polling location of Precinct 5-3

# **Precinct 2-4**

Beginning at the intersection of a powerline and Turk Creek, located approximately at (-92.613254, 31.541135), then south on Turk Creek to its intersection with Cholera Branch, then south on the branch to its intersection with Hwy 71, then northwest on the highway to its intersection with Helms Loop, then east and northeast on Helms Loop to

its intersection with a powerline located approximately at (-92.614705, 31.541936), then southeast on the powerline to the point of beginning.

#### Precinct 5-3

Beginning at the intersection of a powerline and Turk Creek, located approximately at (-92.613254, 31.541135), then south on Turk Creek to its intersection with Cholera Branch, then south on the branch to its intersection with Hwy 71, then southeast on the highway to its intersection with Grays Creek, then north and east on the creek to its intersection with Parsonage Rd, then east on Parsonage Rd to its intersection with Grays Creek Rd, then north on Grays Creek Rd to its intersection with Hwy 8, then west on Hwy 8 to its intersection with Fire Tower Rd, then north on Fire Tower Rd to its intersection with a powerline, then west on the powerline to the point of beginning.

### H. Current Precinct 6-1 is divided to create Precincts 6-1 and 7-5

Polling Location: Precincts 6-1 and 7-5 shall have a consolidated polling location at the current polling location of Precinct 6-1

#### **Precinct 7-5**

Beginning at the intersection of Precinct 6-3 and Hwy 165, then south on the highway to its intersection with East Meade Rd, then west on East Meade Rd to its intersection with Sandy Creek, then northerly on Sandy Creek to its intersection with Precinct 6-3, then east on the precinct boundary to the point of beginning.

#### Precinct 6-1

Beginning at the intersection of Precinct 6-3 and Hwy 165, then south on the highway to its intersection with East Meade Rd, then west and south on East Meade Rd to its intersection with Waggoner Rd, then east on Waggoner Rd to its intersection with US Hwy 165, then north on the highway to its intersection with Clear Creek, then easterly and northerly on the creek to its intersection with the parish boundary, then north on the parish boundary to its intersection with Big Creek, then west on Big Creek to its intersection with Hwy 9, then north on Hwy 9 to its intersection with Lofton Rd, then west on Lofton Rd to its intersection with Precinct 6-3, then south and west on the precinct boundary to the point of beginning.

#### I. Current Precinct 6-3 is divided to create Precincts 6-3 and 7-6

Polling Location: Precincts 6-3 and 7-6 shall have a consolidated polling location at the current polling location of Precinct 6-3

## **Precinct 7-6**

That portion of current Precinct 6-3 that is south of Hwy 8 and west of Howell Rd.

# Precinct 6-3

That portion of current Precinct 6-3 that is north of Hwy 8 and east of Howell Rd.

# J. Current Precinct 7-2 is divided to create Precincts 7-2 and 2-6

Polling Location: Precincts 7-2 and 2-6 shall have a consolidated polling location at the current polling location of Precinct 7-2

#### **Precinct 2-6**

Beginning at the intersection of Precinct 7-1 and US Hwy 167, then south on the highway to its intersection with Rob Wallace Rd, then west on Rob Wallace Rd to its intersection with Fire Break Rd, then west on Firebreak Rd to its intersection with Brunson Rd, then south on Brunson Rd to its intersection with Fralick Rd, then northerly on Fralick Rd to its intersection with a tributary of Chandler Creek located approximately at (-92.548494, 31.535891), the south on the tributary to its intersection with Chandler Creek, then south on the creek to its intersection with Hwy 8, then west on the highway to its intersection

with Fire Tower Rd, then north on Fire Tower Rd to its intersection with Hwy 123, then easterly on the highway to its intersection with Precinct 7-1, then south and east on the boundary to the point of beginning.

#### Precinct 7-2

Beginning at the intersection of Precinct 7-1 and US Hwy 167, then south on the highway for 1.78 miles to its intersection with an unnamed road, then northeast on the road for .129 miles to its intersection with a powerline, the south on the powerline to its intersection with Dyson Creek, then east on the creek to its intersection with S Tower Rd, then northeast on S Tower Rd to its intersection with Dyson Creek Rd, then west on Dyson Creek Rd to its intersection with N Tower Rd, then northerly on N Tower Rd to its intersection with Dry Prong Creek, then west on the creek to its intersection with 145A Rd, then south on the road to its intersection with Orr Rd, then west on Orr Rd to its intersection with US Hwy 167, then south on the highway to its intersection with Precinct 7-1, then south and west on the boundary to the point of beginning.

# K. Current Precinct 7-3 is divided to create Precincts 7-3 and 2-7

Polling Location: Precincts 7-3 and 2-7 shall have a consolidated polling location at the current polling location of Precinct 7-3

## Precinct 2-7

Beginning at the intersection of Rob Wallace Rd and Fire Break Rd, then west on Firebreak Rd to its intersection with Brunson Rd, then south on Brunson Rd to its intersection with Fralick Rd, then northerly on Fralick Rd to its intersection with a tributary of Chandler Creek located approximately at (-92.548494, 31.535891), the south on the tributary to its intersection with Chandler Creek, then south on the creek to its intersection with Hwy 8, then east on Hwy 8 to its intersection with Rob Wallace Rd, then north on Rob Wallace Rd to the point of beginning.

#### Precinct 7-3

Beginning at the intersection of Rob Wallace Rd and Fire Break Rd, then south on Rob Wallace Rd to its intersection with Hwy 8, then west on Hwy 8 to its intersection with Jordan Creek, then south on the creek to its intersection with Rock Hill Rd, then south on the road to its intersection with Grays Creek Rd, then south on Grays Creek Rd (becoming Parish Road 27) to its intersection with Prospect Rd, then east on Prospect Rd to its intersection with US Hwy 167, the north for .122 miles on the highway to an unnamed tributary of Flagon Bayou, then east on the tributary to its intersection with Flagon Bayou, then east on the bayou to its intersection with Airbase Rd, the east on Airbase Rd for .726 miles to its intersection with a powerline, then northerly on the powerline to its intersection with Stuart Lake Rd, then northeast on Stuart Lake Rd to its intersection with the boundary of Precinct 6-3A, then north and east and north on the boundary to its intersection with Hughart Rd, then west on Hughart Rd to its intersection with S Tower Rd, then north on S Tower Rd to its intersection with Dyson Creek, then westerly on the creek to its intersection a powerline, then north for .193 miles on the powerline to its intersection with an unnamed road, then southwest on the road for .129 miles to its intersection with US Hwy 167, then south on the highway to its intersection with Rob Wallace Rd, then southwest on Rob Wallace road to the point of beginning.

# L. Current Precinct 2-1 is renamed Precinct 1-4

- M. Precinct 2-1A, which was created in Section 1 (D), is renamed Precinct 2-1
- N. New Precinct 1-4, New Precinct 2-1 and Precinct 3-4 will maintain the consolidated polling location established in Section 1 (D)

## **SECTION 2**

The redistricting plan entitled Grant Plan 2022, as described below and specifically depicted on maps and electronic shapefiles and block equivalency files submitted to the Louisiana Secretary of State, be and is hereby adopted and such plan shall be utilized for the qualifying for elections in the Fall of 2020 and utilized for the regularly scheduled elections in the Fall of 2022 for Grant Parish, in accordance with Louisiana law.

#### **DISTRICT 1**

District 1 consists of the entirety of precincts 1-1, 1-2, 1-3, 1-4 and 1-5

#### **DISTRICT 2**

District 2 consists of the entirety of precincts 2-1, 2-2, 2-3, 2-4, 2-5, 2-6 and 2-7

#### **DISTRICT 3**

District 3 consists of the entirety of precincts 3-1, 3-2, 3-3 and 3-4

#### DISTRICT 4

District 4 consists of the entirety of precincts 4-1, 4-2 and 4-3

#### **DISTRICT 5**

District 5 consists of the entirety of precinct 5-1, 5-2, 5-3 and 5-4

#### **DISTRICT 6**

District 6 consists of the entirety of precincts 6-1, 6-2, 6-3 and 6-4

#### DISTRICT 7

District 7 consists of the entirety of precincts 7-1, 7-2, 7-3, 7-4, 7-5 and 7-6

#### **DISTRICT 8**

District 8 consists of the entirety of precincts 8-1, 8-2, 8-3 and 8-4
