## Parish of Grant In the Name and By the Authority of The Police Jury of Grant Parish

Motion by Mr. Mark Ball, seconded by Mr. Arnold Murrell and carried to adopt the following Ordinance:

### ORDINANCE NO. 05-2022

An Ordinance to geographically merge precincts, and establish polling places; and otherwise, to provide with respect thereto.

WHEREAS, the Grant Parish Police Jury adopted Ordinance 04-2022 to divide precincts and adopt a redistricting plan after the 2020 Federal Decennial Census;

WHEREAS, the Grant Parish Police Jury hereby certifies that the Grant Parish Police Jury, the Grant Parish School Board and the Louisiana Legislature have completed redistricting following the 2020 Federal Decennial Census;

WHEREAS, the Grant Parish Police Jury, divided a number of precincts in the adoption of its redistricting plan;

WHEREAS, the Grant Parish Police Jury deems it in the best interest of the electoral process to geographically merge precincts in accordance with R.S. 18:532.1(D)(1)(b).

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE GRANT PARISH POLICE JURY THAT:**

#### SECTION 1

The following Precincts are hereby geographically merged:

#### Precincts 1-4 and 1-5 are geographically merged into new Precinct 1-4

The polling location for Precinct 1-4 shall be:

#### Precincts 2-3 and 2-4 are geographically merged into new Precinct 2-3

The polling location for Precinct 2-3 shall be:

Bethel Baptist Church Family Life Center  
8789 Hwy 8, Colfax, LA. 71417

**Precincts 3-2 and 3-4 are geographically merged into new Precinct 3-2**

The polling location for Precinct 3-2 shall be:

Civic Center  
1290 Main St. Colfax, LA. 71417

**Precincts 2-6 and 2-7 are geographically merged into new Precinct 2-6**

The polling location for Precinct 2-6 shall be:

Woodmen of the World Hall  
3232 Dyson Creek Rd., Dry Prong, LA. 71423

**Precincts 5-1 and 5-4 are geographically merged into new Precinct 5-1**

The polling location for Precinct 5-1 shall be:

South Grant Elementary School  
1000 LA Hwy 1241, Dry Prong/Prospect, LA. 71423

**Date of Enactment** – This Ordinance shall become effective immediately upon **approval**.




