WHEREAS, the Grant Parish Police Jury will provide any additional funding beyond any Capital Outlay allocation;



BE IT FURTHER RESOLVED, that the President is hereby authorized to execute contracts and change orders between the Grant Parish Police Jury and the successful Bidder.


