Roberts, duly elected Police Juror for Grant Parish, District 6, whose term of office began on January 12, 2023 for a term of four years, passed away, creating a vacancy in the office of the Police Juror for District 6 of Grant Parish, the Louisiana Secretary of State notified the Police Jury that said vacancy must be filled by appointment on or before January 15, 2026 and a special election shall be set to fill the unexpired term;*

Jurors discussed the Fire District Boards of Control and the lack of transparency with the meetings. After numerous emails and calls have failed to reach several of the boards, jurors agreed to have the Parish Manager send a certified letter advising them that they have 30 days to comply with the Louisiana Open Meeting Laws or the Louisiana Legislative Auditor’s Office will be contacted to get involved. The Fire District Boards must publicly display and agenda informing the dates and times of when meetings are being held along with the topics of discussion.

Motion by Mr. Johnny Jamison, seconded by Mr. Roy Edwards to adjourn. Motion carried unanimously.
