BE IT ORDAINED, that hunting or discharging a firearm or any weapon capable of taking human life, causing injury or property damage shall be prohibited as follows:

- A. In or within one hundred fifty (150) yards of any residence, building or developed site, occupied or semi-occupied area or any place or manner in whereby any person or property is exposed to injury or damage.
- B. Hunting or discharging any of the stated devices across or within Fifty (50) feet of the centerline of any parish road is strictly prohibited.

NOTE; That any person who violates this ordinance shall be subject to fines as follows:

First offence shall be Fifty (\$50.00) Dollars. Second offence shall be one-hundred fifty (\$150.00) dollars Third offence shall be two hundred fifty (\$250.00) dollars
