For the program to continue once the pilot program expires, the parish would need to provide \$69,000.00 for local match funding. Between May 21, 2023 and March 31, 2024, a total of 901 transports were made for Grant Parish with 86% being from Colfax, 11% from Pollock, and 3% from Dry Prong. The jury will discuss the need for funds with the municipalities to determine whether the program can continue.
