These additional holidays may include Memorial Day, Juneteenth Day, Acadian Day (the Friday after Thanksgiving), the day before or after Christmas Day, and the day before or after New Year's Day. The jurors discussed the Grant Parish Mobile Home Park Regulations and whether revisions to these regulations had to be approved by the jury or could the Grant Parish Planning Commission make revisions on their own. Jurors will seek a legal opinion and discuss again.

Motion by Mr. Johnny Jamison, seconded by Mr. Brandon DuBois to declare the Grant Parish Civic Center an Emergency Shelter for Colfax Reunion Rehabilitation Center. Motion carried unanimously.

Motion by Mr. Johnny Jamison, seconded by Mr. Cephas Bowie, Jr. to adopt Proclamation 02-2025; National Gas Utilities Workers Day. Motion carried unanimously.

Motion by Mr. Roy Edwards, seconded by Mr. Brandon DuBois to allow drawing funds up to \$1,500.00 from a district's capital improvement fund on the agreed upon state funded projects from that district only if necessary to cover overages due to price increases on materials needed for the projects in that district. No funds can be drawn any other district account. Motion carried unanimously.

Jurors discussed the current rules for building permits and electrical inspections on reconnects, upgrades, solar panel installations, generator installations, and relocation of service poles. Jurors agreed that the only time a permit or electrical inspection is needed is for new service. A letter will be drafted by the Parish Manager to the electric companies and presented to the jury at the March meeting for approval.

Motion by Mr. Johnny Jamison, seconded by Mr. Winston Roberts to take Spider Lake Drive in District 2 out of the parish road maintenance system. Motion carried unanimously.

Motion by Mr. Arnold Murrell, seconded by Mr. Winston Roberts to use Capital Improvements funds from District 4 for:

- A. Robertson Road
- B. Briggs Road
- C. Springhill Road

Motion carried unanimously.

Motion by Mr. Mike Merrell, seconded by Mr. Roy Edwards to use Capital Improvement funds from District 7 to hard top following:

- A. Dry Prong dumpsite
- B. Bentley dumpsite
- C. Gore Road

Motion carried unanimously.

Jurors discussed installing a dusk to dawn light at the OK's dumpsite. Mr. Johnny Jamison suggested the jury obtain a quote from CLECO and the jury revisit the subject at the March meeting.

Mr. Cody Gongre, Grant Parish Roads Superintendent, updated the jury on current projects from the Landfill and Roads departments.

Motion by Mr. Arnold Murrell, seconded by Mr. Roy Edwards to pay bills as funds become available. Motion carried unanimously.

Motion by Mr. Brandon DuBois, seconded by Mr. Johnny Jamison to adjourn. Motion carried unanimously.
