#### Deposit:

Non- Refundable deposit of \$75 is required to reserve booking date.

## Payment:

- Payment is due upon completion of service in the form of Cash, \$Cashapp or Check.
- There will be a \$25 charge for returned checks.

## **Cancellation Policy:**

- •There will be no charge for cancellations if notified two weeks out from event date. If the event is cancelled without two-week notice, we require a \$100 cancellation fee.
- Should it be necessary to cancel a booking, re-booking may be subject to date/time availability and peak season rate changes.

#### Travel:

• We service mainly Lee County. A travel fee of \$50 may be charged for bookings beyond Lee County area.

# Age:

• Painting is not recommended for children under two years old because their skin is so sensitive and susceptible to irritation from paint. The artist is not responsible for any allergic reactions.

## Safety First:

• For CDC regulations and sanitary reasons, I reserve the right not to paint with anyone with a bad cold or flu like symptoms. In this case PWS Painting kits are available upon request. Brushes and Aprons are cleaned and sanitized before each event. I used acrylic paints that wash off with soap and water.

#### **Breaks:**

• After working two hours, a ten-minute break will be taken. The artist will require access to lavatory facilities and water, and will need to be permitted to use when needed. It is expected that all of the artist's supplies will be kept secure during Bathroom and water breaks. At no time will any guest be permitted access to the artist's supplies equipment without his/her expressed permission, even in his/her absence.

# Stop Time:

• The artist is only obligated to paint for the duration indicated on the contract. The client may request that the artist continue to paint beyond the duration of this contract, however the artist reserves the right to decline an extension without penalty. Extensions are billed at \$40 per half hour to be paid at the time of the request.

# Working Conditions:

• The client is liable for damages and the artist reserves the right to discontinue services if faced with a situation that poses a threat to his/her person, supplies and/or property and the client fail to properly remedy it to the artist's satisfaction. Adverse conditions include, but are not limited to: extreme weather, a hostile environment, violence, illegal activity in or around the vicinity of the painting, and destructive and/or abusive behavior on the part of any person or pet attending.
