To the best of our knowledge, this puppy is presented to you healthy and free from any congenital health defects. If, at the initial visit to your veterinarian, your puppy is found not to be in good health, you must notify us immediately and return the puppy within forty-eight (48) hours of the date of your initial vet visit, along with a signed statement from your vet, (on their office stationary) showing the date of examination and any/all reasons why they believe this puppy is not in good health. If the puppy was shipped to you, you must pay to ship the puppy back to us but once the puppy is returned, we will reimburse the shipping cost. We will pay to re-ship a new puppy at no additional cost to you.

Should a puppy be diagnosed within the first (1) year of life as having any congenital disorder, a second opinion from a licensed veterinarian, not associated nor affiliated with the first must be obtained, at owner's expense. If the diagnoses is deemed to seriously impact the quality of life and/or require continuous medical treatment and/or medication, we will replace or refund the puppy, solely at our discretion, and in a reasonable amount of time. This will be contingent on receiving both Veterinarian reports, diagnosing the same condition.

Should the puppy die within the first (1) year of life due to a congenital disorder, an autopsy must be performed, at owner's expense, and the autopsy must be sent to us to be reviewed by our Veterinarian before a replacement/refund will be given.

We do not and will not pay for any Veterinarian bills for any reason.

We feel confident that our puppies have received great care and that are healthy with most of the common puppy aliments such as; worms, fleas, ticks, lice, intestinal parasites, ear mites, etc., We do not anticipate your puppy having any of them either. However, if by chance they do, these are NOT covered under this health guarantee, as they are common and easily treatable issues by your Veterinarian.

We recommend you follow your Veterinarian's advice on de-worming and vaccinations. However, we are not responsible, nor will we replace/refund a puppy if it has an adverse and/or allergic reaction to any and all treatments, medications and/or vaccinations once the puppy leaves our home.

We strongly advise you not to expose your puppy to any/all public places and to any/all other animals until all recommended vaccinations are complete.

We have represented each puppy to the best of our ability and unless it is stated in this guarantee, nothing should be implied.

We do not guarantee against the following:

- · Hypoglycemia
- Umbilical Hernias
- Dental
- · Color or Markings at maturity
- Temperament or behavior

Be advised, that these puppies are very young when they leave our home to go to yours. Extra care and observation should be given the first few days at their new home. If you notice that your puppy is not eating and/or drinking within two (2) hours of settling in, immediately get it checked by a Veterinarian. Also please be sensitive to the climate. If it is cold, keep them warm. If it is hot, keep them cool. Please puppy proof your home prior to bringing your puppy home. We will not be held responsible for accidental death due to negligence.

GDPR is selling this puppy as a pet. It is recommended that you spay/neuter your puppy by your Veterinarian at the appropriate age. If you breed/stud this dog in any capacity, whether intentionally or accidentally this Health Guarantee will become null & void.
