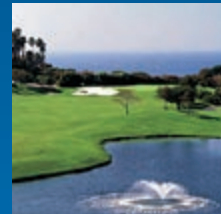
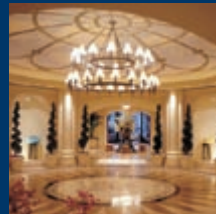
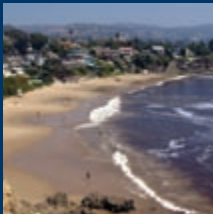

From 2002 to March 2004, Mr. Eckert was the CEO of Docent, Inc., until it merged with Click2learn to form SumTotal Systems in 2004.

Previously, Mr. Eckert spent 11 years with ADAC Laboratories, a global leader in nuclear medicine and radiation therapy planning systems, where he served as CEO (1997 to 2001), Chairman (1999 until its sale to Philips Medical Systems in December 2000), and President (1994 to 1997).

During Mr. Eckert's tenure, ADAC achieved record financial performance and customer satisfaction as he streamlined operations and refocused the business on strategic growth markets. Under his leadership, the company significantly grew its share of the U.S. nuclear medicine market and added new businesses in both the cancer treatment and healthcare information systems industries. In 1996, ADAC was the first healthcare company to be honored with the Malcolm Baldrige National Quality Award.

Before joining ADAC, Mr. Eckert worked in the consulting and finance industries with Goldman Sachs, Summit Partners and Marakon Associates.

He serves on the Boards of Directors of Connetics Corporation, a specialty pharmaceuticals company, and Varian Medical Systems, Inc., a manufacturer of integrated cancer therapy systems. Mark Leavitt, MD, PhD, is Chairman of the Certification Commission for Healthcare Information Technology (CCHIT). The Commission's goal is to build the organizations and processes to certify healthcare information technology products and solutions as meeting interoperability standards. Ensuring that connectivity and information-sharing between different facilities and institutions regardless of affiliation is based on universal standards is a key building block for the development of both local and national health information infrastructures. CCHIT's goals also include enhancing the availability of HIT incentives from public and private purchasers/payers that will help accelerate the adoption of robust, interoperable HIT throughout the U.S. healthcare system.

In his role, Dr. Leavitt leads and provides the strategic direction for the Board of Commissioners as well as working groups that are developing certification frameworks and methods. He is on leave from his role as Medical Director for HIMSS. He brings to CCHIT and HIMSS his technical expertise and hands-on experience in working with IT and management systems in an ambulatory setting.

A HIMSS Fellow, Dr. Leavitt also has been a long-time participant in HIMSS activities. A practicing physician and an innovator in the EHR arena, he founded MedicaLogic in 1985. The company became a pioneering developer of the ambulatory electronic health record and Dr. Leavitt served as its CEO and Chairman until 2002, when GE Medical Systems acquired MedicaLogic. Dr. Leavitt was with GE as the Vice President of Clinical Initiatives until he came to HIMSS.

Dr. Leavitt will be providing an overview of CCHIT's activities and progress to date, as well as an expected timeline for when these standards become a reality for commercial use.

AHRQ's current health IT research and demonstration programs, with an annual \$60-million budget, demonstrate the benefits of information technology, while developing actionable strategies to lower the barriers impeding its widespread diffusion and adoption. He offers the Executive Forum an opportunity to identify which approaches have proven to result in the highest use of electronic health records and computerized patient order entry.

Prior to his present position Dr. Young served in a number of senior healthcare and policy positions and participated in initiatives ranging from Medicare payment policy, graduate medical education, care of the underserved, improvements in the quality of care and health information technology. Improving America's Healthcare System by Investing in Healthcare Information Technology

Despite growing support for the adoption of electronic health records (EHR) to improve U.S. healthcare delivery, EHR adoption has been slow to date due to a fundamental failure of the healthcare IT marketplace. Reasons for the slow adoption include a misalignment of incentives, limited purchasing power among providers, variability in the viability of EHR companies, and limited demonstrated value of EHRs in practice. One recent study estimated a net savings from national implementation of fully standardized interoperability between providers and five other types of organizations could yield \$77.8 billion annually, or approximately 5 percent of the projected \$1.7 trillion spent on U.S. healthcare in 2003. This presentation will review the details of this study and a prescription for helping our healthcare system achieve these potential benefits through EHR adoption.
