



HEALTH WARRANTY AND SALE CONTRACT

The Conditions Of This Sale Are As Follows:

Kristyn Humphrey and Must Love Poodles hereinafter referred to as “seller or breeder”

The remaining balance of _____ is to be paid in cash or via electronic payment method chosen by the breeder at pickup or prior to travel for puppies leaving by transport or this contract is null and void and deposit is forfeited. All travel expenses are the responsibility of the buyer and must be arranged and paid in full by buyer prior to puppy leaving Must Love Poodles. Pickup for your puppy will be _____ through _____ with the time to be determined. If for any reason you need us to keep your puppy beyond the final pickup date, we do charge a \$25/day boarding fee plus any routine veterinary care needed

beyond the first DHPP vaccine. Buyer may forward their nonrefundable reservation fee onto a future litter if necessary for any reason.

Breeder/Seller shall herein be defined as: Kristyn Humphrey

1. A pet puppy/dog is defined herein to be a poodle puppy/dog and embodies the general characteristics of the poodle breed.

2. 30 DAY GUARANTEE: This puppy is guaranteed to be in good health and has been vaccinated and dewormed properly for the puppy's present age. Breeder will provide accurate health records of this puppy. This guarantee is warranted to the original buyer for 30 days. This guarantee does not include uneven bites, malocclusion, un-dropped testicles, umbilical hernia, ear infections, parasites, allergies, hip dysplasia or the repairs of said conditions. Unless otherwise specified, all vet bills for corrective surgery, cosmetic surgery, shots and normal health care, euthanasia, spay/neuter and also transportation costs are the responsibility of the buyer. Puppy must be returned and accompanied with documented proof of illness from licensed veterinarian. Breeder reserves the right to have the puppy examined by a licensed veterinarian of their choice to verify diagnosis before replacing.

3. VETERINARY EXAM: The buyer should have the puppy examined by a licensed veterinarian within 72 hours (taking into consideration holidays, Sundays and travel time). Breeder is not responsible for vet bills. If the puppy is found to be in unacceptable health, a written statement from the veterinarian should be forwarded to the seller and the puppy should be returned within 72 hours (at buyer's expense) for a replacement. Also, in the event the puppy is found to be in unacceptable health, the breeder is to be granted access to buyer's veterinarian records for breeder's veterinarian to review.

4. GENETIC HEALTH GUARANTEE: This puppy is guaranteed against life threatening or life altering congenital defects listed below until its second birthday. If your puppy is affected by any of these diseases as proven by Pawprint Genetics Labs and licensed veterinary documentation, we will offer a replacement puppy as soon as one becomes available OR refund your purchase price for said puppy within 90 days of us receiving DNA result certificate from Pawprint Genetics. Breeder is not responsible for cost of testing puppy or any related veterinary expenses.

Common genetic diseases of the poodle breed covered in this guarantee are:

- Congenital Methemoglobinemia
- Degenerative Myelopathy
- Ehlers-Danlos Syndrome
- GM2 Gangliosidosis
- Multidrug Resistance 1
- Hereditary Juvenile Cataracts
- Neonatal Encephalopathy With Seizures
- Osteochondrodysplasia

- Von Willebrand Disease Type I
- Progressive Retinal Atrophy, Progressive Rod-Cone Dysplasia 4
- Intervertebral Disc Disease

5. **TERMS OF REPLACEMENT:** The dog will be replaced either from the same litter or from a future litter. A proper letter from the vet stating the problem found and the vet's opinion on the viability of the animal must be sent to the seller within 15 days of diagnosis. The breeder will have the final say on whether the original puppy must be returned or not. All the vet bills and travel expenses are the responsibility of the buyer and will not be accepted by the breeder.

6. **SPAY/NEUTER:** This dog is not to be used for breeding under any circumstances. Any breeding, even accidental, voids all guarantees and the following penalties can be applied. If the dog is bred (female) or used to breed (male), accidentally or purposefully, we reserve the right to:

- a. Collect a \$2000 "breeding rights" fee within 30 days
- b. Collect \$1900 per puppy produced in the litter
- c. Report the owner on Bad Buyer/Bad Breeder websites and to any applicable registries
- d. Regain possession of the dog with no refund made to the original Buyer.

Proof of spay/neuter must be sent to Kristyn Humphrey at Must Love Poodles, info@mustlovedoodles.com on or before the puppy is 18 months of age. Please refer to your veterinarian's recommendation for timing of desexing but please note that current research is in favor of later desexing to allow full bone and joint development and reduce incidence of musculoskeletal issues over the lifetime of the dog.

7. **FIRST RIGHT OF RECOVERY:** Puppies are not sold on a trial basis. Please be committed for the life of this dog. The buyer agrees that if the puppy can no longer be kept for any reason, at any age, breeder must be notified. Under no circumstances will buyer be allowed to transfer puppy to a third party without the breeder's consent. If a situation arises in which the buyer cannot keep the dog buyer must contact the breeder and the breeder will help the buyer place the puppy in a new home, but no refunds or exchanges will be given and any and all travel expenses are paid by the buyer.

8. **BUYER OBLIGATIONS:** It is required that you find a reputable veterinarian to keep this puppy up to date on vaccinations and health issues. Breeder assumes no responsibility for the puppy after it leaves the premises, for medical expenses, family disputes, or any other problems you have not thought out. Breeder does not pay veterinarian bills or transportation costs under any circumstances. Please consider all the pros and cons of adding a puppy to your life before you purchase this new member of your family!

Buyer agrees to be responsible in providing a healthy home environment for the dog, including, but not limited to:

- a. Proper, secured space
- b. Plenty of age appropriate exercise
- c. Discipline, including proper socialization
- d. Proper nourishment and healthcare by a licensed veterinarian

- e. Proper licensing required by zoning according to place of residence
- f. Buyer agrees to inform breeder of any health issues that might arise in said puppy so breeder can work to eliminate them from the breed

Failure to follow any or all of the Buyer Obligations noted here will result in the buyer releasing the dog back into the care of the breeder and/or up to \$5,000 in compensation to the breeder to care for, treat and reassess the puppy.

9. DEATH: If the puppy should pass away for any reason (other than physical trauma) during the first year of life a necropsy MUST be performed at buyer's expense and results forwarded to breeder within 15 days. Should the buyer fail to have a necropsy performed as stated above, they forfeit any right to compensation of any kind including replacement of a puppy.

9. INSURANCE: Buyer must sign their puppy up for the Trupanion free 30 day Pet Insurance beginning the day the puppy leaves the breeder's property. Failure to do so will result in their puppy being held at our home until done so, or until we decide to place said puppy with an alternative family.

10. REGISTRATION: Pets are issued an application for limited registration only after proof of spay/neuter has been provided to Must Love Poodles. The only exception is when puppy is going to be shown or perform in formal AKC/UKC events. When dog is registered the name must include MUST LOVE POODLES, MLP, MUST LOVE or LOVE in the registered name.

11. Breeder makes no guarantees on the intensity of color said puppy may develop with age. Breeder also does not guarantee the adult size of the dog.

12. Breeder has the right to, at any time; decide to stop breeding. In this case, no replacement puppies shall be given and this contract is null and void.
