Deadline for filing applications is April 15, 2025. All applications must be postmarked by April 15, 2025 (no exceptions). Applications not postmarked by the 15th of April will not be considered. #### Statewide CSEA Scholarships

CSEA awards 18 \$1,000 scholarships under the **Irving Flaumenbaum Memorial Scholarship** program. **Pearl Insurance** and **MetLife** each sponsor a one-time \$2,500 award.

Irving Flaumenbaum Memorial Scholarship recipients are eligible to apply for the Thomas H. McDonough Scholarship. Applications are automatically mailed to eligible students in late August. For more information, call 1-800-342-4146.

**J.J. Kelly Memorial Scholarship** is open to active members and their eligible dependent children going to a college, trade school or any post-secondary education program. This scholarship will help students who show leadership qualities in their community, school or union with the rising cost of tuition.

This fund was originally created in 1962 when a young attorney, John J. Kelly, Jr. died unexpectedly and left behind a widow and five 4 young children. The Trust was designed to assist in the Kelly children's education. In 1984, when the primary purpose of the trust fund was satisfied under the terms of the Trust Agreement, a separate Scholarship Committee was formed. As a result, the J.J. Kelly Memorial Scholarship Committee was established.
