

2025 Mrs. Casey County Apple Festival

Miss, Ms, & Mrs on stage competition will be begin directly following the PreTeen and Teen crowning

- Pageant is open to all full time residents of Kentucky.
- Entry Fee is \$55 if postmarked/received by September 12, 2025. Entry fee increases to \$70 September 13, 2025 through 11AM the day of the pageant. Entry fees are nonrefundable. Only the contestants admission is included with the entry fee. Admission for anyone over the age of 6 is \$8.
- Contestant must be a natural born female, married only, and can have children. Contestant must be 22 years of age on date of pageant. A birth certificate and marriage certificate are required.
- Clothing for the pageant will be MODEST, meaning no cut outs in the attire, very MODEST cleavage showing in all attire (no low cut in tops that go to belly button), no slits will be allowed higher than mid-thigh, no see-through attire.
- The winner must represent the Casey County Apple Festival County at the Mrs. Kentucky County Fair Pageant in Louisville in January 2026.
- In the event that the winner is unable to attend the state pageant, she must let her director know at least three weeks in advance to allow time for the next available runner-up to register. If the winner does not notify the director in the aforementioned time, she will be obligated to forfeit her crown & sash to the next available runner-up, as well as to refund all expenses the Casey County Apple Festival has provided.
- Winner will be expected to represent the Casey County Apple Festival at a minimum of the following events:
 - Participate in the Casey County Apple Festival parade on Friday, September 26, 2025 (*you must provide your own vehicle and signage*)
 - Cutting of the apple pie at noon on Saturday, September 27, 2025
- Contestants will compete in interview and evening gown.
- Decisions of the judges are FINAL.
