

# 2025 Little Miss & Mister Casey County Apple Festival

Winning couple will compete at the **2026** Kentucky State Fair Pageant in Louisville, Kentucky

**Pageant date: Sunday, September 21, 2025**

**Children's Pageants begin at 2:00PM and will continue on a rolling schedule.**

**The Little Miss and Mister will be the final pageant on pageant day.**

Must submit registration as a couple

- Registration Fees: \$50 per couple
- Each contestant couple must complete an application together.
- Contestants will compete as a couple.
- Little Miss and Mister Kentucky Co. Fair is traditionally held on the opening day of the Kentucky State Fair. Should the state hold the 2026 pageants, the winning couple is expected to compete at the 2026 state pageant.
- Ages: Contestants must be 5 years of age on June 30, 2026 and cannot be 8 on June 30th, 2026. *\*You must submit a copy of each contestants birth certificate with their completed application.*
- Both contestants must be a full time resident of Kentucky.

**Pageant is preregistration ONLY** - Registration and contestant number pick up will be held on Saturday, September 20, 2025 from 10AM-12PM ONLY at the Casey County High School Gymnasium.

Forms of payment: Certified Check, Money Order, or Cashier Check made out to Casey County Apple Festival. Cash will be accepted on September 20, 2025.
