General Contestant Rules:

Contestants must be checked in by 12:00PM EST.

1. Contestants must be single, born a natural female, never been married, never had a marriage annulled and never had a child nor have a criminal record of any kind, (drugs alcohol & etc.)
2. Contestant must be 8 years of age on June 30, 2025 and cannot be 13 on October 31, 2025. A copy of the birth certificate must be submitted with application. We will not accept a photo, email, screenshot or original being shown to us. We must have a copy of the birth certificate with the application for it to be considered submitted.
3. Contestant must be a full-time resident of the state of Kentucky and a U.S. citizen.
4. Forms of payment: Certified Check, Money Order, or Cashier Check made out to Casey County Apple Festival.

6. Contestants holding a 2025 title from any other county fair belonging to the KAFS are ineligible to compete. A contestant will be disqualified from the competition & forfeit any title and prizes if information is falsified on entry form.

*Miss Pre Teen Casey County Apple Festival (open to full time Kentucky residents ONLY) will be awarded to the contestant with the highest score and represent the The Casey County Apple Festival & Fair at the Miss Pre Teen Kentucky County Fair pageant in October 2025 in Louisville, KY.

*Miss Pre Teen Casey County (open ONLY to full time Casey County residents) will be awarded to the contestant with the highest score from Casey County. This winner WILL NOT compete at the

Miss Pre Teen Kentucky County Fair pageant. If the highest overall score is from Casey County the next highest scoring Casey County resident will be awarded the Miss Pre Teen Casey County. There WILL NOT be a double crowned winner.
