In-Game Athletic Trainer Waiver and Release / Assumption of Risk

1. Waiver and Release / Assumption of Risk

In consideration of being provided athletic training and injury care services by Nathan Farhit Sports Performance (NFSP) during practices, games, and related athletic events, I acknowledge and agree that:

- I understand the nature of athletic participation and the inherent risks of injury associated with sports activities, including but not limited to sprains, strains, concussions, fractures, and other bodily harm.
- I understand that an athletic trainer's role is to evaluate, manage, and provide immediate care for injuries but that care does not replace ongoing medical treatment from a physician or licensed healthcare provider.
- I am physically qualified to participate in athletic activities. If at any time I believe conditions are unsafe, I will immediately remove myself from participation.

I fully understand that these activities involve risks of serious injury, disability, paralysis, or death ("Risks"), which may result from my own actions, the actions of others, the condition of the playing surface/facility, or the negligence of the parties released below.

I knowingly and freely assume all such Risks and accept full responsibility for any resulting loss, costs, or damages.

I hereby release, discharge, and covenant not to sue Nathan Farhit Sports Performance, Nathan Farhit, their administrators, directors, agents, officers, volunteers, employees, sponsors, advertisers, and facility owners/lessors ("Releasees") from any and all liability, claims, demands, or damages caused or alleged to be caused in whole or in part by the negligence of the Releasees.

I further agree to indemnify and hold harmless all Releasees from any expenses, attorney's fees, damages, or costs arising out of any such claim.



2. Parental Consent & Indemnification (If Participant is a Minor)

I, the undersigned parent/legal guardian of the minor participant:

- Have read and understood this agreement in full.
- Acknowledge the risks of athletic participation, attest to the minor's capabilities, and consent to the provision of injury care services by NFSP athletic trainers.
- Understand that athletic training services are provided for immediate care and management of injuries, but follow-up medical care may be required.
- Intend this agreement to be an unconditional release of all liability for NFSP to the greatest extent permitted by California law.
- Agree to indemnify and hold harmless NFSP and all Releasees against any claims brought on behalf of the minor.
