Data Privacy Policy

Introduction:

This data policy outlines the principles and practices followed by Startup Triangle Inc. in collecting, using, storing, and sharing data. We value the privacy and security of our users' data. Please read the following to learn more about our Privacy Policy.

In Canada, we adhere to the Personal Information Protection and Electronic Documents Act (PIPEDA), which regulates how private-sector organizations collect, use, and disclose personal information.

For users in Europe (EEA) or the United Kingdom ("UK"), we comply with the General Data Protection Regulation (GDPR), ensuring the protection and privacy of personal data for individuals within the European Union (EU) and the European Economic Area (EEA).

In India, our data handling practices align with the requirements of the Personal Data Protection Bill (PDPB), safeguarding personal information in accordance with Indian data protection laws.

For users in the USA, we follow the guidelines of the California Consumer Privacy Act (CCPA) and other relevant federal and state laws to protect personal data and maintain transparency in our data handling processes.

The use of information received from Google APIs will adhere to the Chrome Web Store User Data Policy, including the Limited Use requirements.

We encourage users to review these policies to understand how we process data and to learn about the rights they have regarding their personal information.

What aspects are addressed by this Data Privacy Policy?

This Privacy Policy outlines our approach to handling Personal Data collected when you use our Service. "Personal Data" refers to any information that identifies or relates to an individual, including what's termed "personally identifiable information" or "personal information" as per relevant data privacy laws. Please note that this Privacy Policy excludes the practices of companies we do not own or control, as well as individuals we do not manage.

2. Data sources

We collect data from various sources, including but not limited to, directly from our users, from third-party sources, and through automated means (such as cookies and log files).

3. Purpose of data collection

The data collected is used to provide and improve our services, to communicate with our users, to troubleshoot and resolve technical issues, to detect and prevent fraudulent activities, and to comply with legal requirements.

Data Use:

- 1. Internal use: We use the collected data for internal purposes such as improving our services, analyzing usage patterns, and for business operations.

d. Your Choices and Control
