Entry fee for the parade is \$20. Please mail or drop off completed entry form: 34555 Casitas Pl Dana Point, CA 92629

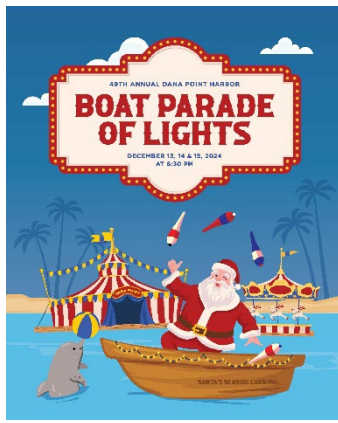
The Boat Parade of Lights has become a tradition of Dana Point Harbor and one that many look forward to experiencing. Your participation and support are GREATLY appreciated.
