Continuing Education / Qualifications – 10%

### Qualifications

#### REQUIRED QUALIFICATIONS:

- A bachelor's degree in occupational safety and health, safety studies, natural science, business or public administration, education, or an allied field.

#### AND

- Four years of professional experience in occupational safety, health, and environmental programs.
- *Note: A master's degree in occupational safety and health, safety studies, natural science, business or public administration, education or allied field may be substituted for two years of the above professional work experience requirement.*

#### OR

- Equivalent education/experience. 5-7 years of construction management, occupational health, and safety, engineering, or related field experience.

#### OR

- Must possess a High School diploma or GED equivalency and a minimum of ten (10) years experience in the Construction Industry

#### Skill to:

1. Maintain Continuing Education / Recertification Qualification Points according to IASHEP Recertification Guidelines.
