CRN now administers the Seriously Mentally III (SMI) Eligibility Determination program across all of Arizona. Behavioral health service providers complete an evaluation for an individual then submit the SMI Assessment Packet to CRN to make an SMI eligibility determination. Services provided by CRN are funded through contracts with Arizona Health Care Cost Containment System (AHCCS), Mercy Maricopa Integrated Care (MMC) and Health Choice Integrated Care (HCIC).
