### DID YOU KNOW...

#	Statement
	...President Kennedy said that he would scatter the CIA into a thousand pieces.
	...The Mafia helped to get President Kennedy elected in Chicago and was angered when Robert Kennedy as Attorney General started to go after the Mafia.
	...Hoover was reaching the age for forced retirement from the Bureau of Investigation, later called the FBI; LBJ, who became president after Kennedy was assassinated, essentially approved Hoover in this role until the end of his life.
	...Kennedy did not agree to leaving the White House, going to a bunker, and attacking Cuba during the Bay of Pigs, angering the military leaders.
	...Hunter, a known CIA assassin, was in Dallas on the day of the shooting.
	...Many usual security steps were not implemented on the day of the shooting. For instance, the windows of the book depository should have all been closed; they were not.
	...A witness said that Oswald was on the second floor at the cafeteria at the time of the shooting and so he was not on the fifth floor from which the supposed shots were fired; the time of this testimony was later changed to make it possible for Oswald to be on the fifth floor at the time of the shooting.
	...The secret service, just before the shooting, were told to step back from the President’s vehicle.
	...The Zapruder film shows President Kennedy’s head being forced back in keeping with a shot from the front.
	...The press secretary, at first report, indicated that there was a bullet entering just above the right temple.
	...Several doctors who had seen the body of President Kennedy after he was shot testified to a large exit wound at the back of the head on the right side.
	...The man who placed the body of President Kennedy said he placed it into a mahogany casket, and that the body was not in a body bag, but the man who removed the body said that it was in a grey-blue shipping casket and the body was in a body bag.
	...The FBI agents assigned to witness the autopsy of President Kennedy reported that there had been what appeared to be surgery to the front right area of the body; to possibly hide the entry wound.
