#	ELECTIONS: DID YOU KNOW...
1	<p>DID YOU KNOW...</p> <p>...In Leviticus 19:35-36, we find:</p> <p><i>You shall do not wrong in judgment, in measurement of weight, or volume. You shall have accurate balances, accurate weights, and accurate ephah (unit of dry measure), and an accurate hin (unit of liquid measure); I am the Lord your God, who brought you out from the land of Egypt.</i></p>
2	<p>DID YOU KNOW...</p> <p>...In Job 31:6, we find:</p> <p><i>Job said let God weigh me with accurate scales, and know my integrity.</i></p>
3	<p>DID YOU KNOW...</p> <p>...in Proverbs 11:1, we find:</p> <p><i>“A false balance is an abomination to the Lord, But a just weight is His delight.”</i></p>
4	<p>DID YOU KNOW...</p> <p>...In Proverbs 20:10, 23, we find:</p> <p><i>Differing weights and differing measures are both an abomination to the Lord, and a false scale is not good.</i></p>
5	<p>DID YOU KNOW...</p> <p>...There are federal, state and local laws that govern elections.</p>
6	<p>DID YOU KNOW...</p> <p>...According to these laws, there are qualifications to be a voter; a voter must be:</p> <ol style="list-style-type: none"> 1. A citizen 2. 18 years or older 3. Not under guardianship 4. Not incarcerated for a felony 5. Not disqualified by corruption in elections 6. A resident
7	<p>DID YOU KNOW...</p> <p>...According to these laws, it is the responsibility of the Registrars (Town Clerks) to be sure voters are qualified.</p>
8	<p>DID YOU KNOW...</p> <p>...Our election officials, under the current system, cannot comply with election law.</p> <ol style="list-style-type: none"> 1. In the Massachusetts system, Town Clerks do not and cannot verify citizenship. 2. In the Massachusetts system, it seems noncitizens are being added to the voter rolls, and Town Clerks cannot address this. 3. Town Clerks were able to check the signatures of a few absentee ballots, but cannot check the thousands of signatures that come in for early voting and vote by mail. 4. The chain of custody for early voting and vote by mail is not secure. 5. Machines are not transparent; we cannot see what is inside the machine and so cannot be assured that it is accurate.
9	<p>DID YOU KNOW...</p> <p>... Because the Town Clerks cannot comply with the law, they are breaking the law if they certify elections.</p>

10	DID YOU KNOW... ...Towns could shift our elections back to 2016 processes, which were simpler, more transparent and made it much easier to comply with the law.
11	DID YOU KNOW... ...The best approach to elections is to use the SHIP process: <ol style="list-style-type: none"> 1. S = Same day voting 2. H = Hand count 3. I = ID required 4. P = Paper ballots
12	DID YOU KNOW... ...The Constitution defines citizenship, and is clear that no state shall abridge of privileges of citizens. <ol style="list-style-type: none"> 1. Go to: www.constitution.congress.gov/constitution 2. Go to: Fourteenth Amendment, Section 1 <ol style="list-style-type: none"> a. “All persons born or naturalized in the United States,...are citizens...No state shall make or enforce any law which shall abridge the privileges...of citizens...
13	DID YOU KNOW... ...Federal law requires all voters to be citizens. <ol style="list-style-type: none"> 1. www.uscode.house.gov; Enter Title: 18, Section 611 2. “It shall be unlawful for any alien to vote in any election...President, Vice President...etc.
14	DID YOU KNOW... ...Massachusetts state law requires voters to be citizens. <ol style="list-style-type: none"> 1. Go to: www.malegislature.gov; Under General Laws, see “Go to General Law: Enter in Chapter: 51, in Section: 1 2. “Qualification of voters”—“Every <u>CITIZEN</u>...
15	DID YOU KNOW... ...Town clerks do not determine citizenship. <ol style="list-style-type: none"> 1. A voter can register at the Town Hall, online, and at multiple agencies; citizenship eligibility is determined, not by the Town Clerks, but by identification numbers in the statewide Voter Registration Information System (VRIS), that is hard-wired into the office of the Secretary of State, and so under the control of a few. 2. Our town officials could facilitate a Memorandum of Understanding (MOU) with the Department of Homeland Security, U.S. Citizenship and Immigration Services (USCIS) to verify citizenship. 3. Go to: www.FightVoterFraud.org; near the top, click on “Request Your Letter;” within #2, at the end: www.perma.cc/EPH6-B43X will provide a sample MOU. <ol style="list-style-type: none"> a. Please note, this website has been changed, but the process may be of value to determine citizenship.
16	DID YOU KNOW... ...A person cannot vote for freedom if he or she is not trained in freedom. <ol style="list-style-type: none"> 1. People coming into the USA from other governance systems, likely cannot vote for freedom.
17	DID YOU KNOW... ...To have a secure election, the Chain of Custody must be secure, which means that there is no risk to the integrity of the ballot from the moment it leaves the voter’s hand until it is counted. <ol style="list-style-type: none"> 1. Are the signatures on early voting and vote by mail verified? 2. In early voting, is the ballot securely held? 3. In vote by mail, is the ballot securely held?

#	ELECTIONS: DID YOU KNOW...
18	DID YOU KNOW... ...Signatures may not be verified. 1. Vote By Mail (VBM) requires checking thousands of signatures, which some Town Clerks say is impossible to accomplish because the numbers are so high and the expertise is so limited.
19	DID YOU KNOW... ...Vote By Mail (VBM) puts our ballots into the hands of others multiple times.
20	DID YOU KNOW... ...Early voting ballots are put into “gym bags,” without locks or security.
21	DID YOU KNOW... ...There are multiple vulnerabilities to the current election process. 1. Town Clerks cannot ascertain citizenship. a. There were multiple first time voters at one participant’s precinct. 2. Early voting is not secure. a. Into a gym bag in the office. b. Ballots could be added or removed 3. Vote By Mail (VBM) a. Handled by others, interference could happen anywhere along the chain of custody 4. Machines are not transparent
22	DID YOU KNOW... ...Our Town Clerks may be at risk of a felony. 1. Because of these conditions that make it difficult to comply with federal and state laws, our Town Clerk could be at risk; there is a federal law that could result in charges against anyone who certifies an election that is not in compliance. 2. DOJ Federal Prosecution of Election Offenses, 8 th Edition_HL_LK.pdf, states on page 14: “1. Election Fraud...Election fraud usually involves corruption of one of three processes; the obtaining and marking of ballots, the counting and certification of election results, or the registration of voters.” (turn over) To access “Federal Prosecution of Election Offenses, 8 th Edition” (See previous page): a. https://www.justice.gov/criminals/file/1029066/dl b. 23	DID YOU KNOW... ...We can protect our Town Clerks. 1. We can go to our town representatives and ask how our town could have SHIP (Same Day, Hand Count, Id, Paper Ballots) voting.
24	DID YOU KNOW... ...The Director of the RMV told Representative Steve Xiarios that it was Town clerks that had the responsibility to verify citizenship, which they cannot do.
25	DID YOU KNOW... ...Mass 4 Fair Elections [ma4fairelections.com] analyzed voting information for 2022 and found, among other facts, that there were 87,000 more votes than voters. The Process: They... 1. Asked for the full voting record from the Secretary of the Commonwealth, which he is legally obligated to do. He did not and is now being sued.

	<ol style="list-style-type: none"> 2. Because they did not receive the full list, they had to go town to town which took months. 3. They analyzed the data, putting all the lists in a database. 4. In coordination with...they ran the list against the NCOA (National Change of Address) database. 5. They ran the voter rolls against lists of those who were deceased. <p>They found:</p> <ol style="list-style-type: none"> 1. 751,317 ineligible or uncertain registration violations. 2. 265,046 votes cast by ineligible or uncertain registrants. 3. 87,231 more votes counted than voters who voted in the 2022 general election; no one knows source. 4. 265,027 apparent voting violations in excess of the legal standard and system accuracy for a valid federal election. Maximum allowable system errors for 2022 January election was 19. 5. And so, certification appears to have been fraudulent and illegal.
26	<p>DID YOU KNOW...</p> <p>...If an election is fraudulent, we will have representatives who have the power to pass laws that are unjust and to vote in justices who will pervert our system of law.</p> <ol style="list-style-type: none"> 1. Elizabeth Warren is pressing to approve justices who will bring progressive interpretation to laws.
27	<p>DID YOU KNOW...</p> <p>...There are PLANS to bring integrity to local elections</p> <ol style="list-style-type: none"> 1. Partners will meet to review information to date 2. The following could become a template for other towns and cities. 3. Partners meet with Town Clerk of Barnstable to fill in any blanks <ol style="list-style-type: none"> a. This includes addressing the fact that someone's family member is not in state and yet is listed as having voted. How did this happen? 4. Meet with a member or several members of the Town Council to see if Barnstable could be changed to SHIP (Same day, Hand count, ID, paper ballots) elections. 5. If this is possible begin to inform residents to prepare for a town meeting to change to SHIP voting.
