Grooming

To begin, it is important to understand what "grooming" means. This is not the grooming that one would do to a dog or a horse. This kind of grooming is preparing someone, in particular children, for sexual activity.

This first block contains information about grooming children for sex. Some of these concepts may be difficult to encounter, but for the sake of all children, we must. Please do press on and through.

		Grooming prepares children to be sexually abused and sex trafficked.
		1. The three major steps of Grooming:
		a. Build trust; Parents might ask if we should trust our teachers and librarians.
		b. Separate the child from the parent: A teacher or librarian might say, "Your
		parents won't understand your desire to change your pronoun, to have sex
		this way, to read this bookYou don't have to tell them; you can tell me."
		c. Sexualize: A teacher or librarian might say, "Here, have you seen this book
		(that includes explicit sexual material)? You might find it interesting."

- 2. The child is then ready for abuse, perhaps, hopefully, not with these authority figures, but they are ready for other adults who are ready to prey on them for sexual abuse and sex trafficking.
- 3. The following quotes are taken from an article on the website of Anderson Advocates, a legal firm specializing in sexual abuse cases. The link to the article, which contains more information on this topic, is included in this block.
- 4. "Predatory grooming is how a child sexual predator uses lies and tricks to manipulate and victimize children and communities."
- 5. "...predators distort reality and take power away from victims (by)...
 - a. (Among other strategies)
 - b. Isolating their victims
 - c. Manipulating family members to trust the predator
 - d. Blurring sexual intimacy boundaries
 - e. Pornography..."

... Abusing a child will weaken him or her.

The American College of Pediatricians detail the devastating impacts of pornography on children.

- 1. From the American College of Pediatricians, "The Impact of Pornography on Children":
 - a. Paragraph 1: "...Consumption of pornography is associated with many negative emotional, psychological, and physical health outcomes...depression, anxiety, acting out and violent behavior..."
 - b. Paragraph 6: "Sexual predators have purposely exposed young children to pornography for the purpose of grooming the children for sexual exploitation...(the children) may become obsessed with acting out adult sexual acts that have been seen, and this can be very disruptive and disturbing...

The following includes excerpts of a Massachusetts senator promoting sexually explicit materials. Unfortunately, he is likely not the only one, but could be viewed as "representing" a perspective that open

access to sexually explicit material can be, somehow, supporting a child, but is, ultimately, harmful to him or her.

This following excerpt is from a hearing on libraries, conducted by the Massachusetts Joint Committee on Education, which took place on January 10, 2024.

		To defend a people group is one thing; to promote books that have sexually explicit
		material is another. Purportedly protecting a people group seems to be the strategy that is
		being used to have sexually explicit materials in our schools.

		 Senator Cyr used <u>All Boys Aren't Blue</u> as an example of appropriate material. Warning: Explicit: Here is a quote from the book: "I put some lube on and got

		3. Archived on the Massachusetts site is a 4 hour and 13-minute video of the hearing
		that included Cyr's bill—S2528. Several bills were covered and testified to in that

		Representative Pease, who was not feeling well, had to wait for 4 hours to make his comments. See his testimony below. It is also interesting that these
		testimonies were over 4 hours after the beginning of the hearing.
		c. 4:02:11: —4:04:24—Rick Brigham, citizen, says it seems there will be
		materials in libraries that can be used for grooming; perhaps it is best to
		remove children from these environments.
		d. 4:04:34—4:06:48—Andrea Murphy, citizen, emphasizes that this bill is
		increasing state power and curtailing parental rights.
		e. 4:07:04—4:09:16—Tinku Alex, citizen, emphasizes the sensitivity of
		children at younger ages, and how exposure can result in addictions.
		f. 4:09:20—4:13:07—Warning: Explicit: Representative Kelly Pease, of the
		Committee on Education quotes from the book, "All Boys Aren't Blue." It is
		interesting to note that the Chair of the Committee asks about reading the
		whole book; he does not seem to recognize or address the issue of sexually
		explicit portions, regardless of other aspects of the content.

...Reiterating what is above, sexually explicit materials can be used to groom our children, preparing them for sexual abuse and sex trafficking, and these materials, generally, will very likely damage them and their futures.

It can be discouraging to see the depth and breadth of this movement among our representatives and within the government schools, government school libraries, and public libraries.
