Opting Out:

- 1. Go to mafamily.org.
- 2. Go to Resources drop down
- 3. Click on Sex Ed in Ma
- 4. Scroll down to "English Sample Opt Out of Sex Ed and Surveys Letter."
- 5. This can be saved, or copied and pasted to make changes.
- 6. Once you have completed the letter...
 - a. Email, mail or personally deliver the letter
- 7. Once you have delivered the letter
- 8. Scroll down to "English Sample Accommodation Request Teacher Letter to Opt out of LGBT Content," which explains further steps to assure your child is protected.
- 9. It is recommended, after sending the letter to opt your child out of sex ed, that you send a personalized letter to the child's teacher to request a broader accommodation than was in the request to the principal.
- 10. For example, if an LGBT book is to be read, your child may be able to go to the library at that time.

Parents United Together in each Town (PUTT):

- 1. To prevent retaliation or ostracizing of your child, it could help to address these issues as a group.
- 2. Reach out to parents in your child's circles to see if they, too, would be willing to opt their children out of sexualized content while in school.
