CONTRACT PRICING POLICIES & PROCEDURES

1. Our turnaround can range from 5-14 business days depending on the season.
2. We **MUST** receive the following to place a job on the print schedule:
 - Artwork
 - Brand/Style/Color of provided items
 - Size distribution (per color/style if there are multiple items)
3. Inventory must be received 4 business days prior to scheduled print date.
4. Changes that are made to an order after it is placed will cause the print date to be rescheduled.
5. Production samples can be produced for orders over 600 pieces, upon request.
6. Orders will be ready for pickup by 4:30 PM on their scheduled print date.
7. Payment terms shall be established at the discretion of Catawba Creations based on the payment history of the customer.
8. Please allow for a 1.5% spoilage on all orders.
We will not charge you for the printing damaged or misprinted garments, but we are not responsible for replacing the damaged or misprinted garments.
9. We do not bear responsibility for lost or missing items once the apparel has left our facility.
