V. Old Business

a) October 2, 2018 Board Meeting - motion to approve J Munie, second B Urban. Motion passes

b) Assessments, delinquencies, foreclosures - President Martin, lot 53 should be for sale in the next 90 days. Lot 215 BOD will be inspecting prior to the bank putting up for sale. No progress on the fines associated with Lot 144.

d) Spillway Update - M Severns/Treasurer Wilken - waiting to get an approved 2019 budget before moving forward. If the budget is approved in December will be working to complete the spillway work prior to the lake coming to full pool. Will be working to have RFP drafted prior to the budget being approved in anticipation of its approval.

e) 2019 Budget Treasurer Wilken - See attachments 2 and 3. Additionally, stated that SLA needs to get out of the escrow business for both shorelines and septic, either now or in the future. This will be formally brought to the BOD at a later date. Discussion on special assessment versus increase in assessment fees.

X. Membership and Guest Recognition

Mark Severns: Please help your neighbors, especially your elderly neighbors with leaf pick-up.

Joyce Munie: We are raffling off a handcrafted fly rod with proceeds to go toward the fireworks fund. Tickets are \$10 each and the winning ticket will be drawn at the December meeting, need not be present to win.

Gary Wilken: Thank you to Bill Urban for all his service to SLA, especially on the lake. Thanks to Deb Martin for the 100s and 100s of hours she has spent helping get the accounting mess figured out, we are getting closer. We appreciate the support of all our members.

Deb Martin: Sometimes we get questions from members that we just can't answer, not because we don't want to or don't know the answer, we just can't share facts that are protected.

a) Ron Rice- Lot 237, 237A

Presented information on lake drawdowns to the BOD. Advised the BOD to address the Neff farm on the west side of the lake that is providing a sediment load to the lake. Advised the BOD that the tower doesn't need to be fixed on the inside and those funds should be used to address the spillway problems. G Wilken, once lake work is done the lake will be allowed to fill to 1' below full pool if the spillway work has been started but not completed.

b) Annette- Scharfenberg Lot 240

Asked the BOD about expenditures related to summer workers, why do we still have one summer worker, why did we have two? and where did the second worker come from? M Severns, first worker wasn't 18 so couldn't operate equipment so a second was hired from the applications received. Were they paid the same? Yes. What about truck insurance? D Martin, the summer workers are 1099 employees and our insurance company has advised us they are covered in the truck and the shop, we will double check. When will the current summer worker be gone? G Wilken, the BOD is looking at that now, he has been kept around to work on common areas and keep up with leaves. He is not generally working eight hour days.

Ray Reardon, Lot 256A, 257: I thought the proxy balloting process was well thought out and appreciated the time and effort that went into the Annual Meeting voting process. Question whether we followed SLA By-laws that allow only one proxy ballot? D Martin, we were advised by legal council that the proxy ballot we followed is allowable under our By-laws as a Directed Proxy is allowed by umbrella proxy in our By-Laws. This language was cleared up in the By-law change made at the Annual Meeting. Will the Directed Proxy be used for the Special Meeting? Yes.

Jeanette Earley, Lot 141: I think members were afraid to vote a proxy ballot because of the signature required. A Walkenbach, thanks for the input, we will change that for the special meeting proxy ballot.

Millie Burgess, Lots 229, 230: Thank you Bill Urban for your dedication to the SLA and the safety of its members. Will he be replaced? Yes.
