Several members addressed the board about the algae/weeds. The board just met with Marine Biochemist about spraying the lake. They will be spraying the lake in a week or two depending on weather. They went over several issues about algae/weeds such as spraying (when you kill algae sometimes it promotes weed growth), mentioned to <u>not burn on</u> <u>shoreline</u> due to the run off into the water, lowering the lake this fall (this will help kill off weed growth), pros and cons of grass carp, and dredging (checking out about 8 inlets). There was much discussion on what to do for the weeds and algae. Bill Walkenbach went over information about weeds/algae.

Lot #126 Stevens/Groesch discussed with the board regarding the sea wall and what they are planning on doing. They went over size and where it is going.

A motion by Bill Urban to except the plans for the sea wall and seconded by Bill Walkenbach. The motion passed unanimously.

Also there were some discussions on lots that need leaves and clean up.

Questions about realtors signs on North Lake Entrance. May have signs moved still up for more discussion.

SUPERINTENDENT'S REPORT: Jim Wilson stated he treated goose nests. He disturbed 25 nest and 145 eggs, 17 nests and 95 eggs on the island. On shore 8 nests and 50 eggs.

OFFICE MANAGER'S REPORT Kristy Barnes stated she worked on three more transfers. Worked on reports. Paid State & Federal monthly deposits. Working on newsletter. Sent out postcards with upcoming events.
