# **Section 6: Membership Meeting Minutes**

Written minutes of all membership meetings must become available on-line to the membership of the Association once approved. be reviewed and approved by the Board at the Board Meeting following the Membership meeting. Within 30 days of being approved, the meeting minutes and any supporting documents will be posted on the Association's website for membership viewing.

Also, the Board reviewed the existing Rules and Regulations that were posted on our SLA website and approved the following revisions at the October 4, 2022, Board meeting.
