 BCI is the state repository for all Utah Criminal History records

- Supported with Fingerprints
 - If we do not receive the charge with good quality fingerprints, BCI cannot put the charge on Criminal history

Right of Access (ROA)

- Anyone can apply at BCI to receive a copy of their own Utah Criminal History
- Once the individual has obtained a copy of their record, they are free to disseminate any way they choose

Costs, Databases Checked and Processing Times for Services

- Criminal History Record Review (\$15)
 - Utah Criminal History (UCH)
 database all information contained in this database will be returned with response.
 - Mailed in Applications- 7 to 10 days processing time with third party release form.
 - In Person- Same day processing if the applicant is making the request in person at BCI. The applicant can deliver the response to the requesting entity.

Criminal History Record Review

- No ordinance or statute in place
- Have applicant fill out application
 - Application is on our website bci.utah.gov
- A third party release form can be signed to release any information found to the requesting entity (that would be you!)

UCA § 53-10-108

- Qualify under city/county ordinance specifying that a background check may be requested
 - Response returned directly to the qualifying entity (that's you!)
 - If the individual turns in a third party release
 - Jesse will explain statutory requirements and scope more in depth

What about FBI Background Checks for Personal Records Checks?



FBI Personal Records Checks

- Without state statute specifically allowing FBI fingerprint-based background checks through BCI, the applicant must request a background check for themselves.
- It can be requested online through the FBI or Mail the information at:

https://www.fbi.gov/services/cjis/identi ty-history-summary-checks

FBI Personal Records Checks

 May be required in combination with any of the other background checks

-OR-

 May be required instead of the other background checks in cases where the applicant has not lived in Utah for a certain length of time

FBI Personal Checks

- Completed fingerprint card (FD-258)
- \$18 money order made out to "US Treasury"
- Letter of Request
- Response returned to applicant who then passes the response to requesting entity
- We recommend that you have the applicant open the return envelope in your presence
- Response time varies- The response time is faster if they request it online (Electronic Departmental Order/eDO) and follow up with fingerprints

Challenge Records

- Any person may dispute or challenge what's on their UCH
- This is done via the Challenge Record process
- Applications are on our website (bci.utah.gov)
- Fingerprints and a \$15 fee are required for application

Government Records Access Management Act (GRAMA) Requests

- Forms can be found on our website (bci.utah.gov)
- Depending on the request, fees may be charged
- Send GRAMA requests to Shanna

Expungements

- Applicants can apply to have certain charges removed from their record, according to Utah statute
- Applications, videos, and qualification criteria are on our website
- Fingerprints and a \$65 fee are required for application
