- The Special Event Unit is a small group that issue temporary sales tax licenses at events such as the Utah State Fair, Utah Arts Festival and many others.
- The temporary sales tax licenses are date specific, location specific and event specific.

• The temporary sales tax license DOES NOT qualify for any exemptions, such as purchases tax free for resale, or any items listed on the TC-721 or TC-721G.

 The purpose of the temporary sales tax license is to ensure that vendors (in state and out of state) are collecting and remitting sales tax to the Utah State Tax Commission so the sales tax can be disbursed back to the community where the event was held.

 The Special Event Unit can issue a temporary sales tax license for situations such as a One Time sale, Door to Door sales, Tool sales and other special situations where sales tax should be collected, but the seller does not have or need a permanent sales tax license.

 Special Event vendors (taxpayers) and events will have an account number ending in SSE. Example, 12345678-002-SSE. The temporary sales tax license itself will have a different format such as 1971-12-0012. The first four digits "1971" is the event number. The second two digits "12" is the year. The last four digits "0012" is the license number.
