Article 22. If an American citizen shall die in our country and no will shall appear, the consul shall take possession of his effects, and if there shall be no consul, the Effects shall be deposited in the hands of some person worthy of trust, until the party shall appear who has a right to demand them, but if the Heir to the Person deceased be present, the property shall be delivered to him without interruption; and if a will shall appear, the property shall descend agreeable to that will, as soon as the Consul shall declare the validity thereof. In support of our secured treaty rights, see the case

Kolovrat v. Oregon, 366 U.S. 178,194, 81 s. Ct. 922 (1961), where the Supreme Court of the United States rendered the following stare decisis:

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, states policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements."

"The Constitution for the United States article 4 section 1 guarantees full faith and credit,"

It Is Ordered, adjudge, from this competent Article III Court that; Cristian Champagne, etc., have been put on notice all accounts are received as of this date: February 21, 2024, through Certified mail return receipt requested, and Christian Champagne is liable for all " Allodial Compensation Damages" and these misrepresented instrument/ bill of attainers/ index numbers/ account numbers etc., are excepted and forgiven as stated in according to Title 12 95a paragraph 2 which is " **Acquittance and Discharged** ," of all 'Debts public and private.
