VERIFIED OBJECTOR'S PETITION

Now comes John Oltmann (hereinafter referred to as the "Objector"), and states as follows:

John Oltmann, who resides at 402 McKinley Street, Village of Worden, in the county of Madison, in the state of Illinois, is duly qualified, registered and a legal voter at such address and that his interest in filing the following objects is that of a citizen desirous of seeing to it that the laws governing the filing of nomination papers for a Nonpartisan Candidate for Election to the Office of Village of Worden Trustee are properly complied with and that only qualified candidates have their names appear upon the ballot as candidates for said office.

Your Objector makes the following objections to the Nomination papers - Statement of Economic Interests of Chelsa Paul as a candidate for nomination as an Independent Candidate for the nomination of the Village Clerk, Village of Worden in Madison County, in the State of Illinois, and files the same herewith, and states that said nomination papers and Statement of Economic Interests are insufficient in law and in fact for the following reasons in violation of 5 ILCS 420/4A-107. Any person required to file a state of economic interest under this Article who willfully files a false or incomplete statement shall be guilty of a Class A misdemeanor under 5 ILCS 4204A-105 of this Act if failure to file a statement within the time prescribed shall result in ineligibility for or forfeiture of office or position.

Generalized Objection. Chelsa Paul (Statement of Economic Interests)
filed on April 16, 2024, at 1:20 PM.

(Pattern of Fraud) Statement of Candidacy filed in the State of Economic Interests documents indicates a pattern of fraud to conceal financial information, which Candidate for Village Clerk Chelsa Paul would be aware of to be false:

Village of Worden Elected Clerk Chelsa Paul is seeking election, who has filed as a Nonpartisan Party and would have knowledge based on her position that her own personal real estate and business holdings are obligated to be disclosed for election based on her position and would know the information to be false or an effort to conceal the financial holdings, which are required to be disclosed by elected officials in the Village of Worden, in the County of Madison, in the State of Illinois. Both being elected, the Illinois Government Ethics would have required officials (Act 5 ILCS 420/) requires that municipal officials to file a truthful statement of Economic interests, including but not limited to all elected officials and candidates for elected

office, which would include the Village of Worden Clerk position. In addition, elected officials who are required to file must disclose the following information:

- Assets valued in excess of \$10,000 held individually, jointly with a spouse or jointly with a minor child or children;
- Assets in a trust, based on the total value of the assets, regardless of whether distributions have been made;
- Creditors of a debt in excess of \$10,000 owed by the filer, jointly with a spouse or jointly with a minor child or children.

Chelsa Paul utilized a Limited Liability Company (LLC) in the name of DASEA Enterprises LLC to conceal business and real estate holdings which she failed to disclose on the Statement of Economic Interests on April 16, 2024, at 1:20 PM involving the following questions, which Village Clerk Chelsea Paul, in her position and duty as Village Clerk, would know to be inaccurate or fraudulent when filing for the Candidacy for the position of Village Clerk.

Question #1. "If you have any single asset that was worth more than \$10,000 as of the end of the preceding calendar year and is held in, or payable to your name, held jointly by, or payable to you with your spouse, or held jointly by, payable to you with your minor child, list such assets below. In the case of investments and real estate, list the city and state where the investment real estate is located. If you do not have such assets, list "none" below."

An individual identified as Chelsa Paul documented the response on the State of Economic Interests as "None."

The violations associated with **Question #1** involve Chelsea Paul's failure to identify the establishment of a Limited Liability Corporation established under the entity name of DASEA ENTERPRISES LLC, the principal address being 2501 Chatham Rd Suite R Springfield, Il established on April 1, 2022, under the names to include the name Chelsea Paul 2501 Chatham Rd, Suite R, Springfield, Il which is different than the address of residency in the Village of Worden, Il, provided by Chelsea Paul in filing as a candidate with the Village of Worden for the position of Village Clerk. In addition, Chelsa Paul failed to disclose real estate holdings to include rental property maintained in the name "Paul, David M and Chelsea L" and the name DASEA ENERPRISES LLC.

Chelsa Paul's conduct and fraudulent or misleading statements as both the Village of Worden Clerk, with responsibilities including issuance of business licenses, gambling licenses and liquor licenses and the concealment of these financial holdings information, creates an ethical violation and a criminal violation involving the failure to disclose real estate holdings held in Limited Liability Corporations, Trusts or under assumed names in violation of 5 ILCS 420/4A-107 Penalties for failure file or false, incomplete forms.

Common Law dictates that acts performed while engaging in illegal activities are null and void. This issue violates 5 ILCS 420/420/4A-107 and the Illinois Ethics Act, as Chelsa Paul's use of the DASEA ENTERPRISES LLC and real Estate holdings invalidates the Statement of Economic Interests form filing with the Madison County Clerks, Edwardsville, IL, on or before the required filing date of November 18, 2024.

Relief Requested: Chelsa Paul's statement to Question #1 from the Statement of Economic Interests required for Candidacy for the position of Village of Worden Board of Trustee Illinois Government Ethics Act 5 ILCS 420 and that the State of Economic Interest is invalidated for a pattern of fraudulent or incomplete answers and that Chelsa Paul's name be removed from the Village of Worden ballot for the elected position of Village Trustee scheduled on the ballot on April 1, 2025.

Chelsa Paul failed to answer Question #2: " Excluding the position for which you are required to file this form, list the source of any income in excess of \$7,500 required to be reported during the preceding calendar year. If you sold an asset that produced more than \$7,500 in capital gains in the preceding calendar year, list the name of the assets and the transaction date on which the sale or transfer took place. If you had no such sources of income or assets, list "none" below." Chelsa Paul provided the following answer, "None."

The other violations associated with **Question #2** involve Chelsa Paul's failure to identify the establishment of a Limited Liability Corporation established under the entity name of DASEA ENTERPRISES LLC, which was primarily incorporated to conceal business located at 115 E Wall St, Worden, Illinois and has been issued both State of Illinois and Village of Worden Liquor and Gambling License for a commercial business which per the State of Illinois, the Limited Liability Corporation would file Form IL-1120 Corporation Income and Replacement Tax return which would be separate from any income required to be filed by Chelsa Paul or DASEA ENTERPRISES, LLC on the required State of Illinois Tax Form IL-1040 involving taxable income. The principal address for the LLC is 2501 Chatham Rd Suite R, Springfield, Illinois, established on November April 1, 2022, to include the name of Chelsa Paul as a principal holder, indicating an address of 2501 Chatham Rd, Suite R, Springfield, Illinois, which is different than the address provided by Chelsa Paul in the filing as a candidate in the Village of Worden for the position of Village Clerk an effort to conceal the financial holdings. In addition, Chelsa Paul failed to disclose real estate holdings used as a rental property business licensed in

the Village of Worden, Illinois, to generate income acquired, which required reporting to
Constitute a truthful response on the Statement of Economic Interests.

Relief Requested: Chelsa Paul's statement to Question #2 from the Statement of Economic Interests required for Candidacy for the position of Village of Worden Clerk violated the Illinois Government Ethics Act 5 ILCS 420, and the State of Economic Interest is invalidated for a pattern of fraudulent or incomplete answers involving the source of income, or that Chelsa Paul be required to provide under oath, testimony and tax returns that the "DASEA ENERPRISES LLC" does not generate income over \$7500. The requested relief is that Chelsa Paul's name be removed from the Village of Worden ballot for the elected position of Village Clerk scheduled on the ballot on April 1, 2025.


A candidate files a Statement of Economic Interest required by the State of Illinois Government Ethics Act, which was enacted to assist in identifying conflicts of financial interests of elected officials, to include the Village of Worden Board of Trustee position. The answers provided by Chelsa Paul should be truthful and accurate, and any misleading information about financial holdings should have been avoided to prevent any confusion involving financial holdings and economic interests that would conflict with the requested elected position. The submission of this affidavit is made with the intent of identifying untruthful or fraudulent information provided by Chelsa Paul.

Chelsa Paul failed to answer **Question #4** “ “List the name of each unit of government of which you or your spouse were an employee, contractor or Office holder during the proceeding calendar year other than the units of government in relation to which the person is required to file and the title of the position or nature of the contractual services.” Chelsa Paul provided the following answer, "None."

The violation associated with Question #4 involves her failure to identify her spouse, David Paul, who was appointed to the Villag of Worden Planning and Zoning Board. David Paul also completed a Statement of Economic Interest on April 20, 2024, at 10:18 AM, including fraudulent responses to **Questions #1, #2, and #4.**


Relief Requested: Chelsa Paul's statement to Question #4 from the Statement of Economic Interests required for Candidacy for the position of Village of Worden Clerk violated the Illinois Government Ethics Act 5 ILCS 420, and the State of Economic Interest is invalidated for a pattern of fraudulent or incomplete answers involving a spouse as an office holder. The requested relief is that Chelsa Paul's name be removed from the Village of Worden ballot for the elected position of Village Clerk scheduled on the ballot on April 1, 2025.

WHEREFORE, your Objector prays that the purported nominating petition and Statement of Economic Interests filed by Chelsea Paul as a candidate for the Nonpartisan nomination to the office of Village of Worden, Il an elected position of Village Clerk be declared by this Honorable Board to be insufficient and not in compliance with the laws of the State of Illinois Government Ethics Act, and that they Candidates name be stricken, and that this honorable Board enters its decision declaring that the of Chelsea Paul name as a Nonpartisan candidate for nomination to the Village of Worden Clerk NOT BE PRINTED on the official ballot for the consolidated elected to be held on April 1, 2024.
