- Schedule your 48-Hour Vet CHECK ahead of time, no extra time will be accepted. A copy of examination (Vet Report) must be sent to BREEDERS email. Kitten must be examined by licensed Veterinarian within (48) hours of pickup, to activate the health contracts and other Guarantees.
- This Agreement represents the understanding between Buyer and Here Kitty Kitty Ragdolls regarding the purchase and care of the kitten.
- Any modifications to this Agreement must be made in writing and agreed upon by both parties, prior to pick up date.
