

Privacy Policy

Protecting your private information is our priority. The ILC247 website is a art portfolio & ecommerce site. By using the ILC247 website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, ILC247 may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
