Panto Camp is unique because our campers learn not just musical theatre skills, but improv, pop singing, and tools to help build confidence and camaraderie along the way. In addition, they finish their week by performing in a Panto! *Cinderella & Prince Charming's Spring Break Ball.* The classic fairytale of Cinderella with a twist performed to music by Taylor Swift, Billie Eilish, BTS, Lukas Graham and more! for their friends and family. There's even an official cast board with headshots and red carpet photos, so get ready to celebrate all our young performers. Your child's never performed in a show before? No problem! All levels of experience are invited to participate, but they need to be between the ages of 6-12.

All campers will receive a Panto Camp water bottle, digital headshot and a Panto Camp Certificate. Our Panto Camp Staff consists of professionals who have performed in or worked on our productions over the years, and they'll be teaching improv technique, choreography, and songs that your kids know and love.

It's very important everyone realizes this is no ordinary camp, as we'll have public performances for everyone to enjoy. Just make sure your child is available for their **live performance on the Saturday,** or please let us know in advance if they won't be able to attend.

Drop off each day will be between 9am-9:15am at **Theatre 68 Arts Complex** 5112 Lankershim Blvd, North Hollywood, CA 91601 (street parking). We will lock the front gate at 9:15am for security, so any late drop offs please text 646.528.8645 and come to backstage door. Panto Camp will rehearse in The Emerson Theatre and perform in The Rosalie Theatre both located inside of Theatre 68 Arts Complex. Lunch will be in the lobby from 12-12:30pm, so don't forget to send them with a nutritious packed lunch which we can refrigerate as soon as they arrive. At the end of each day pick-up will take place starting at 3:15pm. Rest assured that our Camp Instructors will be present at all times that campers are at the **Theatre 68**.

OK, so **WHAT HAPPENS** at Panto Camp? On the next page is a breakdown of what the full week will look like. There will be improv classes, singing classes, dancing classes, rehearsals, and an opening performance on Saturday. Your young superstar(s) will also get to walk the Red Carpet before their show.

### WHAT IS A WEEK OF PANTO CAMP LIKE?

### **MONDAY:**

9am-9:15am drop-off at front door of Theatre 68 Arts Complex. After check-in, we begin each day of camp with morning announcements. On the first day, we take some time to get to know each student with some theatre games and improv work. Don't forget to pack a lunch and small snack that we can refrigerate for you, and to bring a bottle of water each day. Lunch will be 12-12:30. After lunch on the first day is when we will audition each child. Then that's a wrap! Campers are ready to be picked up by your parent or approved guardian starting at 3:15pm.

### **TUESDAY:**

Following check-in between 9a and 9:15a with morning announcements to follow, we will announce roles and after a morning warm up, begin rehearsals for our show. After lunch, we will continue with rehearsals until it's time to go home.

#### WEDNESDAY:

Costume fittings begin on our third day of camp. We will also learn more about all that makes a production soar. From sound technicians to lighting designers, costume designers to prop masters. We will then continue rehearsals for the rest of the day.

### THURSDAY:

Today we will have a special guest to visit and speak with our students about performing. This will be a star from one of our past productions. Who knows who might stop by- Broadway star Shoshana Bean (*Wicked* and *Waitress*)? Olivia Sanabia from Disney's *Just Add Magic*? Kira Kosarin from *The Thundermans*? After lunch will be a full run through of the show.

### FRIDAY:

We begin with a full technical rehearsal of the show where our creative team can make final tweaks. Followed lunch a full dress rehearsal of the show.

#### SATURDAY:

The big day has arrived. Campers arrive at 9am for a final dress rehearsal. Then the campers are invited at 10:30am to walk the red carpet. The campers gather backstage and the performance begins at 11am. (Performance will last 1 hour with no intermission)
