Booking: You can reserve a trailer in advance by paying a \$250 Deposit which will be applied to your Security/cleaning deposit.
Security Deposit: The \$250 security deposit is required for each camping trailer rental and due seven days prior to the Rental start date. This security deposit covers the cost in the event there are missing or damaged items inside or damages to the outside of the camping trailer during your stay. If necessary, additional costs associated with missing or damaged items inside or outside the camping trailer may be charged to your credit card that we have on file. The security deposit may also be used to pay any monies owed to JTNPVTR under this agreement.

Reservations: For reservations made at least 7 days in advance, 100% of the total amount of your stay is due 7 days from the Rental start date.

Cancellation: If you must cancel your reservation, it must be prior to 7 days from the Rental start date to receive a full refund. If you cancel within 7 days from the Rental start date, you will forfeit the \$250 Deposit.

Refunds: No refunds will be given for any reason, including, but not limited to, bad weather, no shows, late arrivals, or early departures.

*I would like to reserve/rent a camping trailer from JTNPVTR. I understand that JTNPVTR must approve the agreement before a reservation can be confirmed. If approved, I authorize JTNPVTR to charge my credit card for reservatioan fee/rental amounts or any damages that I have caused during my rental period. I and JTNPVTR have the right to cancel the reservation under this agreement. If I cancel my reservation more than 7 days prior to the Rental start date, I will be refunded the total amount of rental charges and fees. If I cancel the reservation less than 7 days prior to the Rental start date, the total \$250 security deposit will be charged and nonrefundable. If JTNPVTR cancels the reservation for any reason, all my monies will be refunded.

(1) Definitions: "Agreement" means all terms and conditions found in this form, any addenda and any additional materials we provide at the time of reservation/rental. "you" or "your" means the person identified as the renter on this form, any persons signing this Agreement, and any person or organization to whom charges are billed by us at its or the renter's direction. All person's referred to as "you" or "your" are jointly and severally bound by this Agreement. "We", "our", "us" or "JTNPVTR" means Joshua Tree National Park Vacation Trailer Rentals. "Trailer" means the non-motorized camping trailer identified in this agreement. " Loss of use" means the loss of our right to use the Trailer for any reason because of damage to it or loss of it during this rental. Loss of use is calculated by multiplying the number of days from the date if damage to the trailer until it is repaired or replaced times the daily rental rate.
