1. All Vendor & Sponsor display area locations will be determined by The Draft Card Show in its sole discretion and The Draft Card Show reserves the right to change the layout of the Display Areas at the Event at any time.
2. All Display Area rights are subject to cancellation or changed mandated by the Louisville Slugger Sports Complex or other third party.
3. Vendors shall limit its display to its assigned Display Area and a reasonable distance behind that space. Vendors shall not alter the Event floor without the prior written approval of The Draft Card Show.
4. All Vendors are required to follow all state, federal and local laws regarding taxes.
5. Payment must be made in full to reserve your booth/table(s)/cases.
6. Re-sale or transfer of tables is strictly prohibited. If this occurs, both parties will be permanently banned from this event and all future events hosted by The Draft Card Show.
7. All Vendors and Sponsors will keep its Display Area open for business during the Show Hours or other hours reasonably requested by The Draft Card Show. Early departure requests for Sunday, October 22 must be submitted to event organizers by Sunday, October 15. Written approval for early departure requests will be delivered upon Vendor arrival at the event.
8. All Vendors must be 18 years old. If the Vendor is under the age of 18 they must be under supervision of someone over the age of 18.
9. All Vendor & Sponsors are responsible for their property and show inventory during and not during show hours. Although security will be provided, The Draft Card Show and the Louisville Slugger Sports Complex are not liable for any stolen, lost, or damaged property. All Vendors assume the responsibility of his/her own insurance coverage.
10. The Draft Card Show is not responsible for any lost, damaged, misplaced or stolen items in any way.
11. All Vendors release The Draft Card Show and the Louisville Slugger Sports Complex from any and all liability for any loss, damage, or injury I may incur while participating in the show.
12. All Vendors are responsible for the safety and security of their assigned space and must take all reasonable measures to prevent theft or damage to their property.
13. All Vendors are responsible for any and all damages to the space they have rented and must pay for the repair or replacement of any damaged property. This includes, but is not limited to, tables, table skirts, chairs, rental display cases, or signage.
14. No Vendor will sell any fake or questionable autographs or property such as cards, memorabilia, watches, toys, sneakers etc. If The Draft Card Show believes that a vendor is selling or promoting any property that has questionable authenticity, you will be asked to remove the material from the show. Failure to remove said questionable material within one hour of a formal request by The Draft Card Show will result in forfeiture of your booth space as well as banned from future shows.
15. No refunds for Vendor rental, tables, or displays will be given except in the event of an act of God, such as tornado weather or war that damages or shuts down the venue (Louisville Slugger Sports Complex), or government shutdown because of natural epidemic, The Draft Card Show will have the discretion to provide a full refund or a credit for a future show.
16. Badges will be supplied for dealers and must be worn during all times the venue is open. Lost badges will not be replaced. Replacement badges can be purchased at full retail cost.
17. Dealers are expected to dress and conduct themselves in a professional manner always, creating an exceptional and friendly experience for all event attendees.
18. All Vendors are renting space from The Draft Card Show and that I am responsible for all taxes, fees, and other costs associated with the rental of the space.
19. All Vendors are responsible for the cleanliness and order of my space and that I must keep it in a neat and orderly fashion throughout the show.
20. No outside food is allowed on the turf floor of the event.
21. All Vendors agree to abide by all rules and regulations set forth by The Draft Card Show and the Louisville Slugger Sports Complex. By signing page 1 of this contract or checking the agreement box through online registration, you understand that all disputes arising out of or relating to this agreement shall be brought in the courts of the State of Illinois, and you consent to the exclusive jurisdiction and venue of such courts.
