- 1.) Under no circumstances will this kitten be sold, leased or given away, or sold to any pet shop, research laboratory or similar facility. Buyer must contact Seller if they can no longer keep said kitten. The kitten will be kept indoors and not be allowed to roam outdoors unsupervised.
- 2) If the kitten is found to be neglected or mistreated, purchaser will surrender said kitten to Seller immediately.
- 3) Under no circumstances is the kitten to be destroyed prior to approval by Seller. Failure to do so will render any guarantee null and void.
- 4) Buyer agrees to spay or neuter this cat/kitten by the age of 6 months or within 30 days after purchase. Seller agrees to provide registration papers for this cat/kitten upon presentation of a veterinarian certificate of spay or neuter.
- 5) Any disagreements resulting from the purchase of this cat will not be published by buyer, seller or their associates/surrogates on social media or on any Internet sites. Damages for violation of this clause will be \$5000

HEALTH GUARANTEE: Health is guaranteed for a period of 72 hours from the time the kittens leave the possession of the seller. To validate this guarantee, you must take the cat/kitten to your veterinarian (at your expense) within this said time. If the cat/kitten is found after such examination to have any type of life threatening problem it may be returned and a replacement kitten will be offered as available. All shipping expenses from the date of sale are the responsibility of the Buyer. If the cat/kitten is returned to the breeder, the cat/kitten must be tested for FIP, FIV, and FeIV at Buyers expense. Once the cat/kitten leaves the possession of the breeder (Painted Cats Jim Lubbad) cannot be held responsible for any veterinary bills or charges regarding this cat/kitten.

Buyer agrees to isolate these kittens from other pets for a period of fourteen days. Feeding according to the breeder's recommendations.

Should the kitten die within one year of age as a result of a congenital defect (unknown at time of sale), said cat/kitten will be replaced if an appropriate necropsy is preformed by a licensed veterinarian and a veterinarian certificate is provided showing proof of cause of death. A replacement



kitten of comparable quality and value will be made at the discretion of the breeder/seller. Seller may also elect to give a monetary refund of purchase price.

This contract is legally binding to all parties involved. It applies only to the Buyer and the Seller in this transaction and is non-transferable to other parties. In the event of default, the Buyer will be legally liable for any and all attorney fees and or collection fees and all related costs necessary to resolve this matter. It is also agreed that any legal matters pertaining to this contract will be held in the State of Wisconsin, Milwaukee County.
