

Trial Period The Montessori Method is a unique approach used when educating a child. During the first week there will be notes or conferencing about the transition from the teacher. The teacher will use his/her best discretion to determine if the environment is working. If he/she feels confident she may ask your child to continue for the next week and son on. Further enrollment may be discussed when the teacher feels it is appropriate.
