This 6 year old white male was seen at the request of Mr. Joe Walden, General Probation Officer, for evaluation of a behavior problem. All information was obtained from Mr. Waldron.

The patient was released from Fresno County General Hospital on 3/9/65, having been admitted on 2/26/65. He had been treated at Fresno County General Hospital on 2/25/65 and 2/26/65 for severe beating across back with an electric cord administered by his mother. Mother had been warned in October 1964 by the District Attorney after beating her son. Mother now is in the Fresno County Jail on charges of felonious child beating. She allegedly stated that he was a behavior problem at home, which provoked excessive punishment. Two brothers responded to physical abuse but not patient.

During his hospitalization he apparently displayed erratic and unpredictable behavior and had to be restrained.

.Two foster homes were unable to cope with him since discharge from the hospital.

According to Mr. Walden, this boy had rapid mood chages, from being cooperative and docile, to being overactive and destructive.

Born 5/31/58, he was the 5th of 9 siblings. Parents, of Polish-Cherokee heritage, were separated. Mother, about 29, apparently treated children well except the beating given to the patient. Fallier, 29, had a long police record of drunkenness, theft, failure to provide, etc., whereabouts unknown.

This well developed, well nourished 6 year old buy was pleasant and cheerful, responded to direction. He was restless, had an obvious speech impediment. He appeared to be of average normal intelligence.

During the interview he showed no signs of psychosis. History indicated an adjustment reaction of childhood(conduct disturbance).

The recommendation was made to hospitalize the patient on the psychiatric unit at the Fresno County General Hospital for a period of observation to determine whether or not he was psychotic. Tranquilizers would also be of benefit. However, patient may have to be committed to Napa State Hospital for further study.

MOST RECEIT OFFENSE

Douglas was recommitted to the Youth Authority on 5-24-73 for Robbery, Assault With a Deadly Weapon on a Peace Officer. He was accepted for NRCC on 6-11-73, arriving at the Clinic 11 days later.

Originally, the charges had been Burglary, Armed Robbery, Strong Armed Robbery, and Assault With Intent to Commit Murder. California Highway Patrol officer stated to Fresno County Sheriff's Department that a radio broadcast advised that a fellow officer was following a stolen vehicle occupied by three suspects. This involved a high-speed chase. The Highway Patrol officer parked his vehicle, waiting for the suspects, who came by with the other patrol officer in pursuit. At this time, shotgun fire was observed coming from the suspects' vehicle, the pellets striking the windshield of the patrol vehicle. As the suspects' vehicle was entering the mountains on Highway 163, patrol officer leaned out of the right window, firing two shots at the suspects' vehicle with a shotgun. The weapon then jammed. When the malfunction was corrected, two more shots were fired. The shotgun then jammed again. The patrol officer laid down the shotgun, leaning out the right window to fire at the suspects with his hand gun. The patrol officer at that time was hit in the face and head with a shotgun blast from the suspects. He fell back in the front seat against the driver. The

driver slowed to return his partner to the hospital in Fresno. However, the patrol officer claimed that he was not seriously injured and they continued in pursuit. It was then observed that the suspects spun the head. The patrol officer got out of the patrol unit with his sidequa dease, and observed the driver of the suspects which he get and on the driver's side. Upon getting out the was in a defensive position, appearing to have a recepen in his hand, prompting the patrol officer to fire at the driver; aiming at his chest area. The other patrol officer fired a shotgun. The driver of the suspects vehicle dropped to the ground. The second suspect was found in the vehicle, being directed to come out, then being handcuffed; The third suspect escaped from the vehicle but was later found a short distance away, hiding in tall grass. The suspects were believed to have been involved in an armed robbery and also assault with a deadly weapon earlier. The vehicle was identified as one which had been stolen. The driver was killed.

John Stankewitz, 14, Doug's brother, stated that he had been at home when Doug and Eddic Davis drove into the yard. Doug went in the house to take a shower, Eddle staying outside, sniffing paint. All three then left the home, going to Frient. The weapons were in the vehicle at the time. John stated that Eddie and Doug had told him that they had borrowed the weapons to go rebbit hunting, although John admitted that they shot at a school in the Friant area. While in Friant, they observed a youth riding a 10-speed bike. Eddie stopped the car, John got out, beating the youngster with his fists, taking the bicycle, placing it in the back seat of the vehicle. John went on to say that they had returned to Pinedale and had observed a patrol vehicle following them. Increased his speed in an effort to evade the patrol car. John denied shooting at the patrol vehicle, saying that Eddie had sbot. John claimed that Eddie was driving 90 to 100 mph and told John to load the weapon, John being in the back seat at the time. Doug was on the passenger side in the front seat. John claimed that he told Eddicato run into the patrol vehicle when it came close. When the officers fired, John hid on the floorboard, When Eddie got the loaded shotgun, Doug steered the vehicle while Eddle shot at the patrol vehicle. John later stated that Eddie and Doug traded places so Doug-could drive while Eddie fired at the officers. They then traded places again. John continually denied shooting at the officers, although admitting loading two of the weapons for Eddie. Prior to stopping, Eddie gave Doug a wallet, saying, "Here's that old man's wallet -- hold it for mei" Doug replied, "Okay." John denied knowledge of the wallet.

Pathological examination of the body of Eddle Charles Davis revealed there were four entrance and four exit holes in the body, causing instant death.

-PROGRESS IN PROGRAM:

Douglas is a 5'9" 159 lb. 18.4 year old youth who was first committed to the CYA in May, 1972, for treatment rather than for punitive reasons.

STANKEWITZ, Douglas YA #0 67

Douglas is the fifth of ten children born to the marriage of his natural parents, a marriage that was never stable because of his parents constant incarceration in adult authority facilities. His father is presently incarcerated in Soledad State Prison and his mother was just released from CIW. Her whereabouts are not yet known.

Lack of early parental guidance, delinquent peer associations, and poor environment has contributed to Douglas' delinquent history. His arrest record, going back to 1965, consists primarily of being out of control, running away, and battery. Douglas has been incarcerated on his current recommitment offense of robbery and assault with a deadly weapon on a Peace Officer since May 24, 1973, a total of 3.4 years.

Goals established for Douglas when he arrived at YTS were: (1) no assaultive behavior, verbal or physical, against any ward or staff, (2) no pressure or intimidation directed at any other person or groups of persons, (3) no conspiratorial action against any other person or group, (4) no lewd or bizarre sexual behavior, this to include verbal or physical action.

These goals were met very poorly by Douglas. He has received numerous behavior reports since his arrival. On four occasions he received continuances for very serious offenses, including battery on staff and interfering with another person in the performance of such person's authorized duties by force. The latter offense occurred on January 17, 1976.

Douglas arrived at YTS on March 26, 1975. He was assigned to trade 501, delivery of foodstuff where he carried average grades. He has been assigned to several other trades since his arrival and has often been commended by his instructors for his good work. Douglas has also taken academic classes in U.S. Government and Algebra with a B average. Many of his instructors have stated they wished more students were like Douglas in applying themselves to their assigned trades.

Douglas has had trouble on his companies, as evidenced in his repeated history of assaults, threats, and interference. However, he has shown considerable positive response to individual counseling. He has learned that his extremely impulsive behavior has resulted in nothing but problems for him, and he has developed increasing ability to deal maturely with reality. Since his last Board appearance on September 2, 1976, Douglas has had no negative behavior reports.

PLACEMENT INFORMATION:

Douglas and this writer have repeatedly tried to contact various members of his immediate family for possible placement, but to no avail. His mother has been notified of Douglas' impending parole by his aunt, but she has made no attempt to contact him. We most recently called his aunt, Mrs. Mary Cox, again on September 30, 1976, to see if she would accept him for placement in her home. At this time she notified this writer that she and her husband could not accept Douglas because they had five children and could not afford another person. Also, she was a very nervous person and would not be able to handle being constantly worried about Douglas' whereabouts.

At this time it is recommended that Douglas be given independent placement.

EVALUATION:

Because of the progress Douglas has made staff feel that he should be referred to parole. It is felt that he has made recognizable progress toward a positive self concept and a mature attitude. Staff also feel that Douglas is amenable to a good working relationship with his Parole Agent because of his hopeful attitude about parole. He can be led by his peers. Therefore, full time employment and participation in a school program will be essential to establish his independency.

. FAMILY HISTORY:

Prior to Douglas' incarceration in Juvenile Hall, he was residing with his mother and his brother, John, at 572 East Herndon, Apartment #11, Fresno, California.

Father:

William Robert Stankewitz, the minor's natural father, is a thirty-nine-year-old truck driver, employed by the Semper Truck Lines in Pinedale, California. Mr. Stankewitz indicates that he has been working for the same trucking company for the past ten months, and that prior to this time, he was employed by the Flemming Logging Company in Auberry.

Mr. Stankewitz reports that he has gained a tenth grade education in Fresno, and is presently in good physical health.

Mr. Stankewitz reports that he has an extensive arrest record, and has been seen by psychologists and psychiatrists during his incarceration in penal institutions. Mr. Stankewitz's last arrest took place in 1968, as a result of a robbery. He spent four years incarcerated in Soledad, San Quentin, and seventeen months in a state conservation camp in Jamestown, California. He reports that he was released from prison on December 24, 1971, and is presently under the parole supervision of Agent, William Hernandez.

Mother:

Marian Louise Stankewitz; the minor's natural mother, is a thirty-eight-year-old housewife, who reports a ninth grade education, and good health.

Mrs. Stankewitz indicates that she has a delinquency history, and has been seen by psychologists and psychiatrists only while incarcerated in prison.

Mrs. Stankewitz was last incarcerated for involuntary manslaughter on October 24, 1971. She was released on August 16, 1972, from the California Institution for Women at Frontera, and was placed on work furlough under parole supervision in Los Angeles. While in Los Angeles, Mrs. Stankewitz worked inspecting and packaging bathing suits and silk screening, and returned to Fresno in March, 1973. Mrs. Stankewitz is presently under the parole supervision of Agent, Sharon Owens.

Marriage:

The marriage of Douglas' natural parents took place on January 18, 1955, in Fresno, California. Mr. and Mrs. Stankewitz report that they were separated approximately seven years ago, while living in Fresno, California. This is reported to be the only formal marriage for either parent.

Other Children:

Mr. & Mrs. Stankewitz report that Douglas has three older brothers, two older sisters, four younger brothers and a younger sister. Frank Montgomery, age twenty-two, is presently incarcerated in Duell Vocational Institution as the result of a parole violation involving assault. Gary Lewis, age nineteen, is presently incarcerated in the Fresno County Jail as the result of numerous vehicle code citations received while he was on parole. Glenda Stankewitz, age seventeen, has experienced Juvenile Probation in the past as the result of violations of Section 601 of the Welfare and Institutions Code. Willie, age sixteen, is presently experiencing Juvenile Probation in Fresno County and residing in Auberry. Wilma, age sixteen, Roger, age twelve, Rhonda, age eleven, Theodore, age nine, and Rodney, age seven, are all dependents of the Fresno County Juvenile Court and are presently residing in foster homes within the county. John, age thirteen, is presently incarcerated in the Fresno County Juvenile Hall, and is a coparticipant with his brother, Douglas, in this matter.

Home and Neighborhood:

Mrs. Stankewitz reports that prior to Douglas' incarceration, that he was residing at 572 East Herndon, Fresno, with his mother and with his brother, John. Mrs. Stankewitz reports that they were living in a one-bedroom home which Mrs. Stankewitz was renting for \$100.00 per month. She states that the boys were sleeping on a couch in the living-room, and that the home was adequate, but crowded for the three individuals. Mrs. Stankewitz reports that John came to live with her when he was released to his mother on furlough from Juvenile Hall. She states that Douglas came to live with her at the request of his parole agent. The agent felt that Douglas should be with his mother rather than his aunt, Marquez, in Auberry.

Activities:

There were no family activities reported by Mr. & Mrs. Stankewitz, as they are separated and John and Douglas were living with their mother. The two boys had been living with their mother approximately one month prior to the incidents which necessitated their incarceration.

Community Agencies:

The Stankewitz family is presently known to most of the local law enforcement agencies within Fresno County, the State Department of Corrections, the California Youth Authority, the Fresno County Department of Mental Health, and the Fresno County Department of Public Welfare, as a result of the previous activities of the entire family.

2. MINOR'S HISTORY:

Development and Health:

Douglas was born as the result of a normal pregnancy and birth, and was in good health during early infancy. Mrs. Stankewitz reports that he developed whooping cough at about eighteen months of age, and was subsequently hospitalized. Mrs. Stankewitz thinks that this was the last time that Douglas was committed to a hospital for any length of time, but is unsure of his medical history during the time she has been incarcerated or during those periods of time that Douglas has not lived with her.

Mrs. Stankewitz is not certain if Douglas experienced the usual childhood diseases and states that as far as she knows, he is presently in good physical condition. She is unaware of any medical problems that Douglas may have.

Work and Activities:

Mrs. Stankewitz reports that Douglas has no employment history, and was supposedly seeking work due to the fact that he had dropped out of school.

Personality:

Since Douglas' first contact with this department and the Juvenile Court, at the age of six years, he has been identified as a person who displays erratic and unpredictable behavior, a person whose moods rapidly change from cooperative and docile behavior to that of being very overactive and destructive.

As Douglas has matured and developed physically, he has gained the muscular prowess allowing him to physically intimidate others, and to ventilate his hostility through the expression of force and violence.

School Record:

Douglas last attended Sierra Joint Union High School where he is reported to have been in the ninth grade. According to the Dean of Sierra, Douglas has not attended school since March 9, 1973. Douglas entered Sierra on January 30, 1973, shortly after his parole from the California Youth Authority. The Dean of Sierra High, reports that between January 30, 1973, and March 9, 1973, when Douglas was officially enrolled in classes at Sierra, he attended school for a total of nine days. He further reports that during these nine days, Douglas didn't always go to classes just because he was at school on those nine occasions.

Douglas has not attended school since he moved to his mother's home in March, 1973.

There is no written school report available for the Court's consideration as Douglas has not experienced more than a few hours of instruction since his parole in January, 1973.

Parole Adjustment:

According to officials at the California Youth Authority, Douglas was paroled from O.H. Close on January 11, 1973, and returned to Fresno at that time. He had been living with his aunt, Marquez, in Auberry until March. At this time, Douglas moved into his mother's home on East Herndon at the request of his parole agent.

Douglas had not attended school on any realistic basis and was supposedly looking for work while living in his mother's home. Evidently, his parole agent felt that Douglas would be more able to maintain adequate behavior in the community if he were working rather than going to school.

Douglas had been residing in the community approximately three months after his parole from a California Youth Authority institution when the incidents at hand occurred.

Psychiatric/Psychological Reports:

Douglas was first seen by a psychologist when he visited Doctor Simmang on March 11, 1965.

Subsequently, he has visited Doctor Ziering, on March 3, 1965. At that time, Doctor Ziering identified Douglas as an aggressive boy with wide fluctuations in his disposition, and stated that at the age of six years, Douglas was already a psychiatrically maladjusted boy.

During Douglas' supervision by this department, he has been seen by Donn Beedle on April 1, 1965; Stephen Graham, a Psychiatric Social Worker at Napa State Hospital, on June 16, 1965. Mr. Graham diagnosed Douglas as having an adjustment reaction of childhood with a conduct disturbance. Douglas was in the process of undergoing three consecutive ninety-day commitments to Napa State Hospital for observations in 1965. At this time, psychiatrists at Napa State Hospital were checking the possibility of Douglas having neurological brain damage and the prognosis for the use of anticonvulsants to control his behavior. Based on a Napa State Hospital Report, dated November 12, 1965, it was found that anticonvulsant medication would not affect his behavior and officials from that institution recommended that Douglas be placed in a foster home where his tantrums could be controlled.

Douglas was subsequently seen by Doctor Lee Sannella, from the Department of Mental Hygiene, who conducted a psychiatric examination of Douglas in June, 1965.

Mark Zeifert, performed an EEG on Douglas on May 6, 1970, and at that time, indicated that the results of Douglas' tests indicated "abnormalities". Doctor Zeifert found that there was a suppression of voltage in Douglas' left temperal area.

In a report from Doctor Charles House on July 24, 1970, it was learned that Doctor House viewed Douglas as "an impulse ridden child whose psychological development has been so chaotic as to render negligible any form of controls over basic impulses".

All of these Psychological and Psychiatric Reports are available in Douglas' Probation folder for the Court's consideration.

Prior Record:

See attached.

Additional Offenses:

Douglas was booked in the Fresno County Juvenile Hall on March 18, 1973, when he was found in a drunken condition inside a public tavern. Douglas was subsequently released to his parole agent on March 20, 1973.

3. CO-PARTICIPANTS:

The minor's brother, John Stankewitz, age thirteen, is presently detained in the Fresno County Juvenile Hall pending disposition of robbery by force and fear, and assault with a deadly weapon upon a peace officer, on May 7, 1973, at 11:00 a.m.

Eddie Davis was shot and killed by officers of the California Highway Patrol on April 24, 1973, when he jumped from the vehicle he was driving and appeared to have a weapon in his hand, as he turned to face the officers. The officers fired at Davis at this time killing him instantly.

4. MAINTENANCE/RESTITUTION:

Based on the Fresno County Probation Office Financial Statement, it was found that William Stankewitz is financially able to reimburse the County of Fresno in the amount of \$80.00 per month or \$2.66 per day for the cost of services rendered.

Restitution in this matter is the result of damage done to the California Highway Patrol vehicle as the result of shots fired at that automobile during the high speed chase involving Douglas and his coparticipants. There is also an extreme amount of damage done to the vehicle driven by Douglas and his coparticipants as the result of gun fire directed towards it by California Highway Patrol officers. There is also a matter of restitution for the medical treatment received by Officer Reid and the owner of the automobile that Douglas took in the robbery.

This officer believes that due to the fact that Douglas has never worked and he will probably not have an opportunity to earn restitution money, that restitution is an unrealistic topic in this issue.

5. ANALYSIS:

Douglas is deeply entrenched in a behavioral pattern founded on aggressive behavior in which he has used tantrums and force as coping mechanisms. He exhibits very little control over his impulses and tends to behave without regard for consequences.

Due to Douglas' assaultive personality and his disregard for the person and property of others in the community, this officer feels that there is no alternative but a recommitment to the California Youth Authority at this time.

This officer seriously doubts the possibility of Douglas being rehabilitated in such a facility, but feels that he must be confined and restrained in a maximum security institution for the good of the community. Perhaps, through extensive counseling and treatment, Douglas may be releasible back to the community at some future date.

6. RECOMMENDATION:

It is recommended that the Court find said minor's true name to be Douglas Roy Stankewitz.

It is recommended that Douglas Roy Stankewitz remain a ward of the Juvenile Court, in charge of the Probation Officer, that he be temporarily removed from the custody of his parents, and recommitted to the California Youth Authority for the period of time prescribed by law.

It is further recommended that Fresno County pay for said minor's maintenance in accordance with Section 912 of the Welfare and Institutions Code of the State of California, and that the parents of said minor reimburse Fresno County through the Probation Office in the amount of \$80.00 per month, until further order of the Court.

It is further recommended that said minor be detained in the Fresno County Juvenile Hall, or the Fresno County Jail, if necessary, until such time as the Sheriff of Fresno County is able to deliver him at the time and to the place designated by the California Youth Authority.



DIAGNOSIS: Dysrhythmia, Grade II, generalized.

REPORT: One does see at times an alpha rhythm of 8 cps in the posterior leads. Much of the record consists of 4-6 cps some what irregular and higher amplitude slowing seen primarily in the anterior and temporal leads. Rather frequently one also sees 3-4 cps rhythmic slowing throughout the record. The response to HV and PS is normal with a good bilateral driving response to flash.

CLINICAL INTERPRETATION: The record is considered as significantly abnormal suggesting a widespread chronic dysfunction, probably of a chronic nature.

This is a twelve year old white male child who is brought in by the Probation Officer. The boy was previously seen in this office by Dr. Simmang, at the age of six years, at which time he was also brought in by a Probation Officer, because he is apparently a behavior problem,

The child had been studied at the Fresno General Hospital, and he had also been treated for a severe beating administered with an electric cord by his mother. About six months earlier, the mother had apparently beaten the child also, and had been warned by the District Attorney about this. But after the beating of February, 1965, the mother was arrested and apparently served a jail sentence. The boy is quite aware of the fact that his mother beat him, and he is aware of the fact that she used to drink excessively at that time; but he states that she no longer drinks and, in fact, when her brother visited recently with some wine, she told him he could not drink the wine in her home. He speaks of his mother as being "rnean" and when asked to give details, he merely states that she seems to side with his younger brother who is ten years old and, even when he is not the guilty one, he is blamed for things that the brother does. He has similar complaints about the counsellors at the Juvenile Hall where he is now a resident, and offers similar complaints about the Napa State Hospital where he was studied in 1965. In fact, he had three ninety-day periods of study there at that time. 'The boy says that he lived six years in a foster home in Sebastopol - he liked the people there, he liked them very much - but he decided to come home to his mother, and then he didn't go back, and in the meanwhile, since that foster home is licensed for only three children and they have taken in a third child, he cannot go back there although he would like to. He knows of another foster home to which he would like to be sent,

He insists that he did nothing wrong on the occasion of the present admission to the Juvenile Hall; but that his brother had done something wrong, and when the police came to look for him, he felt innocent and he walked right up to the policemen, although his brother ran away. The policemen then brought him to the Juvenile Hall,

The boy tells me that his step-father is in prison, and his own father died when the patient was a baby, and he doesn't know the cause of death. The step-father is in prison for robbing a bank. His 18 year old brother is in jail, but he doesn't know for what reason. Apparently a 13 year old brother has had difficulty with the juvenile authorities, and a 10 year old brother is in trouble in school.

The Probation Officer told me that the patient actually did not get along well in the foster home in Sebastopol, and the woman in charge finally decided that she couldn't keep him any longer. He has run away from four foster homes but, according to the Probation Officer, the boy has never been delinquent. His chief problem is a sudden loss of control of during which he becomes abusive, uses vile language, and actually becomes combative. On one occasion, when he was put in a padded room in Juvenile Hall, he was observed actually biting the walls. A report from the Napa State Hospital indicates that he required physical restraint there, as well, and he was only six years old at the time. The boy tells me that he has never had an F in school, has had only one D, and most of his grades are A, B and C. He boasts about his ability to do arithmetic and, when I tested him, he was quite bright at addition and subtraction – even without the use of pencil and paper.

His ambition is to be either a teacher or a policeman - especially a policeman who works eight hours a day and then in his spare time owns a dump truck and makes even more money at that business. He says he learned about this because the mother of one of his faoster-brothers in the foster home was keeping company with a policeman, who did just this and, apparently, this man became an idol to the patient.

Throughout the interview and the neurological examination, he was most cooperative, interested, and very pleasant. It was a real joy to examine him and I can understand how disappointing it must be for those who work with him, when he slips from this pleasant, cheerful attitude into a wild rage.

There is an obvious speech impairment, and the fingernails are bitten. He states that he stopped wetting the bed about four months ago, and it happens now only when he is cold; so enurses still exists.

Palpation, percussion and auscultation of the skull are negative. Palpation and auscultation of the carotid vessels is normal. The neck is rather sensitive, because of enlarged lymph nodes associated with acute tonsillitis, and the right tonsil has a hemorrhagic ulcer on it:

Examination of the cranial nerves, including visual fields, fundi, pupillary reflexes, extraocualr movements, muscles of mastication, facial expression, soft palate and tongue is negative. Cranial nerves VIII and XI, intact. Weber, mid-line.

General sensory examination, including stereognosis and skinwriting, is normal.

Examination of the reflexes reveals them to be 1 plus bilaterally in the uppers, and 3 plus bilaterally in the lowers, except that I think the left knee jerk may, perhaps, be slightly more active than the right. Abdominals active and equal in all four quadrants; cremasterics bilaterally active and equal. No pathologic toe signs. Trunk-thigh sign of Babinski, negative.

Examination of the motor system reveals nothing remarkable insofar as gait, station, equilibrium, etc., are concerned; but the left handclasp is slightly stronger than the right handclasp, by the method of Jamar. On two measurements, he had a grip of 41 pounds in the right hand and 42 pounds in the left hand the first time; and 40 pounds in the right hand and 41 pounds in the left hand the second time. Since the patient is right-handed, he should normally have about 10 pounds greater strength in the right hand than in the left.

The EEG, as will be seen from the attached report, is abnormal. The disturbance seems to be greatest in the left temporal area.

DISCUSSION: There is ample evidence, in the review of this history, for this child to have a neurotic disturbance, and the bitten fingernails and the enuresis are expressions of this. It may well be that the patient's emotional instability is also an expression of this; however, we cannot neglect the "soft" neurological signs and the EEG disturbance.

This boy has apparently been moved around from place to place, in accordance with his behavior, and I would suggest that he be kept in one place for awhile, while an attempt is made to influence his behavior through supervised medication. I doubt very much if this can be done in a foster home, since the boy will not respond to the authority of the foster home as he would to the authority of the Juvenile Hall or some institution.

I would outline a program for the boy, with the first attempt being made to influence his behavior by treating him with Dilantin Sodium, 100 mgm, twice daily; and, if he is able to tolerate this and his behavior does not improve, then I would increase it to three times daily.

If he fails to respond to Dilantin therapy, I would suggest a trial with Dexedrine, 5 mgm, three times daily, after meals. If he fails to respond to these drugs, then I would attempt to use ordinary tranquilizing agents, at progressively increasing dosage in an effort to control his emotional lability. Perhaps Mellaril or Thorazine would be more effective than the other agents. It seems to me that this type of treatment could be supervised in the Pediatric Clinic or in the Department of Mental Health.


