The undersigned acknowledges that any activity in which the Participants participate with Fetch RI may carry with it the potential for human or animal injury, death and/or damage to property. ## Rules of Fetch RI facilities (aka The Fetch Room)

All parties entering The Fetch Room must acknowledge and agree to abide by the conditions set forth in order to participate in activities at Fetch RI facilities (aka The Fetch Room). A signed acknowledgment and agreement is required.

<u>Initials:</u>	
	1. All dog(s) must be at least 6 months old to enter The Fetch Room.
	<ul> <li>2. Prior to entering The Fetch Room we require health records from your veterinarian evidencing the following:</li> <li>DPv /DHPP titer test result or vaccination record(s)</li> <li>Current Rabies vaccination (required only if multiple dogs from different households attending)</li> <li>Negative fecal test results for newly adopted dogs only (We will retain a copy on site until expiration.)</li> </ul>
	3. No food or drink of any kind is allowed inside The Fetch Room (only bite size training treats & bottled water are allowed.)
	4. All dogs must <u>enter</u> The Fetch Room on leash; <u>collars must remain</u> on the dog(s) at all times. No dogs are to be left unattended at any time.
	5. You acknowledge that all dogs (with a maximum capacity of 5 dogs inside The Fetch Room at one time) have met prior to entering The Fetch Room and that play behavior is known among dogs.
	6. For the safety of all dogs, <i>no children</i> under the age of 12 are allowed inside The Fetch Room.
	7. Maximum occupancy at any time is limited to 8 people and 5 dogs (excluding Fetch RI staff.)
	8. No alcohol or drugs of any kind are allowed on Fetch RI premises including the parking lot, The Fetch Room and all surrounding areas. You will be asked to leave, without refund, if alcohol or drugs are being used.
	9. The Fetch Room is under surveillance and is being recorded. Any misuse of the facility, equipment, or violation of any of the Rules set forth as above will be acknowledged as forfeiture of any future use of the facility and no refund will be given.
	10. Dog owners need to notify Fetch RI staff prior to renting The Fetch Room facility or booking any type of party event of any medical condition or allergy that a dog may have.
	11. You agree to clean up any elimination accidents (urine and/or feces) that occur while in The Fetch Room using the provided cleaning materials. <b>Upon exiting</b> The Fetch Room, <i>you agree to mark the area where elimination happened with an orange cone and agree to notify Fetch RI staff of any elimination accidents that occurred.</i> Your time in The Fetch Room will not be extended for any reason related to clean up. If you fail to clean up and/or notify Fetch RI staff of an elimination accident you will not be allowed to use The Fetch Room in the future.
