In consideration of my child/children participating in cheerleading, tumbling, and related activities at NJ PREMIER ALL STAR CHEER TRAINING CENTER, LLC (“NJ PREMIER”), located at 1500 Campus Drive, Units 101, 102, 103 & 104 Morganville, NJ 07751 (“the Gym”), I, the undersigned parent/guardian, acknowledge and agree to the following:

Authorization for Emergency Medical Treatment

I authorize NJ PREMIER staff, coaches, and representatives to act on my behalf in the event of a medical emergency involving my child/children. This includes securing emergency medical treatment, transportation, and hospital care if deemed necessary. I accept full financial responsibility for any medical expenses incurred as a result of such treatment.

Acknowledgment of Risk

I understand that cheerleading, tumbling, stunting, jumping, conditioning, and related athletic activities involve inherent risks including, but not limited to, falls, collisions, contact with other participants, equipment failure, and physical exertion that may result in serious injury, permanent disability, or death. I voluntarily assume all risks associated with my child’s/children’s participation in NJ PREMIER activities.

Medical Certification

I certify that my child/children is/are physically fit to participate in cheerleading and tumbling activities. I confirm that my child/children has/have no known medical conditions, injuries, or physical limitations that would prevent safe participation. If my child has a medical condition, I agree to notify NJ PREMIER in writing prior to participation.

Liability Waiver and Release

I, on behalf of myself, my child/children, and our heirs, executors, administrators, and assigns, hereby release, waive, discharge, and hold harmless NJ PREMIER ALL STAR CHEER TRAINING CENTER, LLC, its owners, directors, coaches, employees, contractors, agents, representatives, volunteers, and facility owners from any and all claims, demands, damages, rights of action, or causes of action, present or future, arising out of or related to any injury, illness, death, or property damage sustained by my child/children while participating in any NJ PREMIER activities or while on the premises of the Gym.

Supervision and Conduct

I understand that NJ PREMIER is only responsible for athletes during their scheduled class, practice, lesson, or team activity time. NJ PREMIER is not responsible for supervision before or after scheduled activities. I agree to be responsible for my child’s/children’s behavior while in the Gym and for any damage caused to the facility or equipment due to misconduct or negligence.

Media Release

I grant NJ PREMIER the irrevocable right and permission to photograph, film, videotape, or otherwise record my child/children during participation in activities and to use these images or recordings for promotional, advertising, marketing, website, and social media purposes in any format without compensation.

Personal Property

I understand that NJ PREMIER is not responsible for lost, stolen, or damaged personal items, including but not limited to phones, jewelry, clothing, bags, or other valuables. Athletes are not permitted to wear jewelry during participation, and any removed items are the responsibility of the athlete.

I confirm that I have read and fully understand the contents of the NJ PREMIER ALL STARS 2026–2027 Registration Packet, including all rules, expectations, and policies. By signing this agreement, I agree to comply with all outlined regulations and understand that failure to follow these rules may result in suspension or immediate dismissal from the program at the discretion of NJ PREMIER ownership, without refund.

Commitment Acknowledgment

1. I understand the financial and time commitments required to participate in the NJ PREMIER ALL STARS Cheerleading Program.
2. If my athlete voluntarily leaves or is dismissed from the program for any reason, I acknowledge that all monies paid (including merchandise, deposits, hotel reservations, tuition, and fees) are non-refundable and non-transferable, and I forfeit any rights to those items.
3. I am aware of the strict attendance policies in place. I understand the importance of consistent attendance for my athlete's success and team performance. I also acknowledge and accept the commitment that Black Out Weeks require from both my family and my athlete, and I agree to fully comply with all expectations during these periods.
4. Athletes are committing to the NJ Premier program as a whole, not a specific team. Team placements, positions, stunt groups, and tumbling passes may change at any time at the discretion of NJ PREMIER staff for the success of the team.

Code of Conduct & Expectations

As a member of NJ PREMIER ALL STARS, I agree to:

1. Represent the gym with integrity, maturity, and respect at all times, especially while wearing NJ PREMIER attire or attending events.
2. Conduct myself appropriately during all NJ PREMIER events, meetings, practices, fundraisers, and competitions.
3. Refrain from public or private arguments with NJ PREMIER staff. Any concerns will be addressed privately and professionally.
4. Not engage in slander, gossip, or negative behavior, including:
 - Negative comments about NJ PREMIER, its staff, or other athletes
 - Gossip about other gyms, teams, coaches, or athletes
 - Public negativity on social media, Facebook groups, or any online platforms
5. Avoid altercations of any kind with competition staff, NJP staff, NJP parents, or athletes from other programs.
6. Maintain professionalism and good sportsmanship at all practices and competitions.
7. Abide by the decisions of coaches during practices and competitions without argument or interference.

8. Disrespecting any NJ PREMIER staff member may result in immediate dismissal from the program.
9. There is to be NO tumbling or training permitted at any other facility in the state of New Jersey without prior approval by NJ PREMIER owners and coaches.
10. Athletes may not be on any other cheerleading team while participating on a team at NJ PREMIER without explicit permission from NJ PREMIER owners and coaches.

Practice Etiquette

1. Arrive on time for all practices, competitions, and scheduled events.
2. Wear assigned practice wear for every practice. If an athlete loses or misplaces practice wear or bows, they are responsible for purchasing replacements.
4. Store personal items (phones, bags, etc.) in designated areas.
5. Phones must be turned off and not left on the gym floor.
6. No yelling or parent coaching from the viewing area.
7. All questions for coaching staff must be asked outside of practice times.

Communication & Responsibility

1. It is the parent's responsibility to stay informed through Band, email, or text messages.
2. Only NJ PREMIER staff may communicate with competition officials.
3. Parents, friends, or athletes may not approach competition officials for any reason.
4. Coaching, routine, and team decisions are made solely at the discretion of NJ PREMIER staff and are not up for debate.

Social Media Policy

1. Do not post anything negative about NJ PREMIER, its athletes, staff, or other gyms.
2. Do not engage with anonymous social media accounts or rumor pages.
3. Do not post routines, choreography, or team information without permission.
4. Always represent NJ PREMIER and yourself positively on all platforms.

Mandatory Practices

Beginning September 8, all practices, choreography sessions, camps, additional practices, and team activities are considered mandatory. Attendance is essential for team safety, routine progress, and overall team success. Failure to attend mandatory practices may result in routine changes, loss of position, suspension, or removal from the team at the discretion of NJ PREMIER staff.

All parents/guardians acknowledge and accept full financial responsibility for all costs associated with membership in NJ PREMIER ALL STARS.

These costs include, but are not limited to:

- Monthly Tuition
- Practice Attire
- Choreography Fees
- Uniform Costs
- Skills Camps
- Warm-ups
- Bows
- Competition Fees
- Travel Expenses
- Private Lessons
- Clinics
- Pro Shop Purchases
- Showcases
- End of Season Events
- Any additional items or services provided by NJ PREMIER

Payment Expectations & Late Fees

1. Monthly Tuition is due by the 26th of each month prior.
2. A \$25 late fee will be applied if payment is not received by the 1st.
3. Team Fee Monthly Payments are due by the 12th of each month.
4. A \$25 late fee will be applied if payment is not received by the 15th.
5. Tuition covers training and does not guarantee performance opportunities.
6. Vacations, time off and Gym Closings will NOT be prorated.

Payment Methods & Account Requirements

1. All customers must have a valid debit/credit card on file.
2. If tuition is not paid by the 1st, the card on file will be automatically charged including late fees.
3. Any failed payments due to insufficient funds, declined cards, or expired cards will incur a \$25 service charge if the account is not settled within 5 days.
4. It is the parent/guardian's responsibility to update payment information.

2026–2027 FINANCIAL OBLIGATION AGREEMENT

Account Standing & Participation Restrictions

All accounts must be in good standing to:

1. Try out for teams
2. Participate in practices
3. Participate in competitions
4. Receive uniforms or apparel
5. Attend private lessons or classes
6. Make Pro Shop purchases

NJ PREMIER reserves the right to:

1. Sit an athlete from practice
2. Remove an athlete from routines
3. Deny participation in competitions
4. Withhold uniforms/apparel
5. Suspend participation until account is current
6. Payments made toward overdue balances will be applied to outstanding fees at NJ PREMIER's discretion.

Withdrawal, Refunds, & Additional Fees

1. NO REFUNDS will be given under any circumstances.
2. All funds paid are non-refundable and non-transferable.
3. All tuition and team fees must be paid in full even if the athlete does not complete the season.
4. If an athlete is removed from the program for behavior or policy violations, all balances remain due.

Quitter's Fee

1. A fixed \$500 Quitter's Fee will be charged to any athlete who withdraws after July 10th.
2. A fixed \$750 Quitter's Fee will be charged to any athlete who withdraws after October 1st.
3. All other fees remain non-refundable.
4. This fee covers administrative costs and the impact on the team.
5. The Quitter's Fee is due immediately upon withdrawal and will be automatically charged to the payment method on file. It is not an optional or negotiable charge once the withdrawal conditions are met.

2026–2027 FINANCIAL OBLIGATION AGREEMENT

The Quitter's Fee is waived only if:

- The athlete relocates out of state
- The athlete has a documented season-ending injury

Financial Obligation

Participation constitutes a full-season financial commitment. Families remain responsible for outstanding tuition, fees, competition costs, travel, uniforms, quitters fees, and other expenses as outlined in the Financial Agreement.

NJ PREMIER reserves the right to send delinquent accounts to collections, and parents/guardians will be responsible for all collection costs.

If an athlete loses or misplaces any part of their designated team practice wear, they will be required to purchase a replacement at their own expense.

Acknowledgment & Agreement

Enrollment in NJ Premier All Star Cheer signifies acceptance of this Financial Policy. These terms are designed to protect the integrity of our program and ensure fairness to all athletes and families. Adherence to our policies is a condition of participation.
