## **WAIVER & RELEASE OF LIABILITY**

NJ PREMIER, an affiliate of gym facilities owned by NJ PREMIER ALL STAR CHEER TRAINING CENTER, LLC located at 165 Amboy Road Morganville, NJ 07751 (the "Gym"), I hereby authorize the staff at NJ PREMIER to act for me according

to their best judgment in any emergency requiring medical attention, and I hereby waive any and all claims for personal injury, illness, and/or property damage against NJ PREMIER and its directors, officers, agents, employees, contractors, representatives and any volunteers in any way associated with NJ PREMIER.

I agree and understand that participation in cheerleading, tumbling, or any other activity that involves motion, rotation, and/or height, carries with it the risk of injury. I agree and understand that all medical expenses incurred will be the responsibility of the parent or guardian. In lieu of a medical certification signed by a medical doctor, I state that I have no knowledge of any physical injuries or impairment that would be affected by the named child's/children's participation in any program at NJ PREMIER.

NJ PREMIER cannot assume responsibility for children left unattended in the Gym. Parent/Guardian(s) are responsible for the conduct of their children at all times in the Gym. All children, attended or unattended, are expected to respect the Gym and the personal property and equipment located at the Gym and other patrons of the Gym. Under no circumstances does NJ PREMIER assume any liability for injuries, accidents or any mishaps, whatsoever, which may occur when a child is left unattended.

I also expressly grant NJ PREMIER the right to film, videotape, photograph, or record my child/children. I give NJ PREMIER the irrevocable right to use, display, digitally enhance and/or alter in any manner the film, videotape, photograph or record of my child/children and use in any promotional activities to include, but not limited to, broadcast, television, cable, motion picture, videotape, DVD, CD, or any published articles.

## NJ PREMIER REGISTRATION AGREEMENT

2. I understand the financial commitment and the time commitment needed to participate in the NJ PREMIER All Stars Cheerleading Program. If for any reason I can not fulfill my obligation or my athlete is removed from the program all money, merchandise, deposits, hotel reservations, etc. will NOT BE REFUNDED. I also give up my rights to any of these items.
3. I understand that as a member of the NJ PREMIER ALL STAR Program, I must hold the ideals and morals that the NJ Premier All Stars abides by. I also agree to conduct myself in a mature and respectful manner when attending competitions and all other events and functions.
4. I understand I must act appropriately at all NJ Premier hosted events, meetings, fundraisers and competitions.
5. I will not fight/argue with the NJ Premier staff publicly or privately. If a conversation needs to be had it will be professionally and privately.
6. I will not slander NJ Premier All Stars on Social Media, Facebook Groups, etc.
7. I will not get into any fights or altercations with competition staff, NJP staff, NJP parents or members of other gyms.
8. I will act respectfully and will maintain professionalism at all times when wearing NJ PREMIER attire and representing my gym.
9. I understand that I am not able to participate in any practices or classes until this form has been signed and returned to the gym.
10. I understand shall I not abide by the code of conduct I may be removed from the program at the owners discretion; and no refunds will be given.
11. NJP maintains the right to refuse and/or terminate services at any time.
12. Good sportsmanship, polite manners and good disposition are mandatory at practices, classes and competitions.
13. It is the athlete's responsibility to wear the correct practice wear to every practice.
14. Personal items such as cell phones, school bags, or gym bags must be stored in the proper place during practice.
15. All cell phones must be turned off before practice starts.
16. Cell phones left lying around the gym floor will be removed from the gym.
17. NJP is not responsible for lost or stolen items.
18. NO GOSSIP about any other teams (All-Star or school).
19. NO GOSSIP about a child on your team or another team.

20. NO GOSSIP about coaches or staff. It is much better to address a problem than to listen to idle gossip.
21. NO PROFANITY at gym or competitions.
22. Athletes must arrive at all practice, competitions or any scheduled events on time. Punctuality is a must.
23. During practices, please keep your opinion to yourself. All team and routine decisions are left to the discretion of the coaches.
24. All concerns or questions for coaching staff may not be addressed during scheduled practices.
25. NEVER post any negative comments on social media.
26. DO NOT ACKNOWLEDGE or comment on anonymous Twitter accounts.
27. DO NOT POST anything that reflects negatively on NJP, your teammates or yourself.
28. No one can yell onto the floor or try to make contact through the parent viewing area during practice or tumbling classes
29. It is the parent's responsibility to know what is going on with your child's team. Team/Program Bands will be used for updates and last-minute changes especially on competition days. Email or Text messaging may also be used.
30. Parents, relatives, friends or cheerleaders are never allowed to speak with competition officials for any reason.
31. There will be no arguing or questioning of the coaching staff's decisions at competitions.
32. Anonymous emails/ letters/texts, etc. will be ignored.
33. The Owners/Gym Director may change, add, or subtract any rule at any time.

### FINANCIAL OBLIGATION AGREEMENT

1. All parents/guardians must understand that they assume full responsibility for all costs incurred as a member of NJ PREMIER ALL STARS including, but not limited to, gym registration/tryout fees, monthly tuition, practice outfits, choreography fees, uniform fees, skills camp, warm ups, bows, competition fees & any other items or services purchased or rendered to NJP. It is expected to make all payments in full of those items, regardless of any circumstances that may arise. For example, dismissal from the team, switching to a new team, dropping a level, missing competitions.
2. All payment due dates must be met or late fees may be apply. Monthly Tuition is due by the 1st of the month after the 10th you will incur a \$25.00 late fee. Team Fee Monthly Payments are due by the 15th of each month or a \$25.00 late fee will be applied.
3. Tuition pays for training. It does not pay for the right to perform.
4. Vacations or time off will NOT be prorated.
5. All customers must have a debit/credit card on file. If you do not pay your monthly tuition by the 10th of the month your credit card will be automatically charged tuition, and you will incur a \$25.00 late fee.
6. Any payments resulting in non-sufficient funds, declined credit cards, expired credit cards, returned checks and electronic debits, etc. will incur a \$30.00 service charge. It is your responsibility to update your information with us if it changed (ex: bank acct number, card number, expiration date, etc.)
7. All accounts must be in good standing to try-out for the 2023-2024 season as well as continuing to participate in practices, competitions, and other events.
8. NJ PREMIER reserves the right to sit an athlete out of practice, or to remove an athlete from their routine for failure to keep up with financial obligations.
9. Any payments received for an overdue account will be applied to the athlete's account items at the gym's discretion.
10. All tuition / fees must be current before an athlete may collect any clothing / uniform or any other retail items.
11. Athletes with an outstanding balance may not schedule or participate in private lessons. They are also prohibited from taking classes or making Pro Shop purchases until the balance is up to date.
12. If an athlete chooses to leave, or is asked to leave NJ PREMIER for any reason before the season is over, any and all funds are completely nonrefundable.
13. **There will be a \$350.00 Quitters Fee for any athlete who quits after 7/05/2023. This fee will be charged to the card on file immediately after quitting.**
14. NJ PREMIER reserves the right to turn over all delinquent accounts to collection agencies and the parent / guardian will be responsible for all additional costs incurred.
15. **CREDITS ONLY** will be received for any competitions missed or for any fees paid towards the season due to unplanned circumstances out of our control; Cancelled competitions, COVID-19.
16. There will be NO REFUNDS! All team fees and tuition must be paid in full; even if athlete does not finish out the 2023-2024 Season. NO EXCEPTIONS.
