- A Cram, with Cram I'd come back into town and I could tell if there was somethin' up, ya know, cause I would know there was a party that transpired or somethin', ya know. Cause I would say, "who was in the house here with you?" He'd say, "nobody". Well I knew what brand of cigarettes he smoked and w-w-who the hell is smoking these non-filtered cigarettes then? And y-y-you'd catch him in it. I, I, I'd always catch Cram in lies and he was always covering....
- Q Did you ever notice any new property in your house after returning home, like for example, anybody's ring, wallet...?
- A J-jackets and sweaters and stuff like that, yeah, ya know, or some of it, w-we had guests over the other night and they left a sweater here, they left a jacket here.
- Q But they never came back and picked it up?
- A Nope. I says "Why don't you take it to 'em?" "No", he says, "they'll come back for it." I think the one time I found a uh sweater in the living room and then I once found a jacket in the laundry room. I say "who the hell does this belong to?" It was somebody that Cram had known.
- Q Do you ever remember any other occasion when you woke up one morning and there was a body in the house and Rossi was there other than....?
- Well, ya know, here again, just like I explained to you that to me it, it sounds almost impossible for thirty people to have been killed in the house in '77, say middle of '76 to '78. Cause I was never around that much. I wasn't around. I know, I know there was a lot of stuff going on in the house, but, ya know. Because, see, Cra-Cram, even after we'd get into arguments and stuff he'd always want to make his way back, he'd always want, ya know, like keys to the house and keys to the vehicle. That was a big thing with all of them guys, they always want to make sure they have keys to vehicles and keys to the house, ya know. Then Gordon, my uncle, he says I was crazy for lettin' everybody have fuckin' keys to the house.
- Q During 1977, John, can you recall how often you were gone and over what period of time?

- A Well whenever we'd go out of town we'd be gone anywhere from a week to fourteen days.
- Q Was it generally business?
- A Yeah, but see now don't forget, girls had keys to my house too.
- Q Let me ask you this, when you were out of town would it be of record, I mean is there some way in PDM records that we'll know you were gone.
- A Oh for sure, yeah, yeah. Just take a look at the files in 1977 the files in 1978. Inside the files will be the airline tickets, uh, meal tickets, uh hotel receipts.
- Q And you traveled alone?
- A No. Always with one other person. A lot of times with Rossi, um....
- Q Ever with both of them?
- A No.
- Q Maybe one or the other?
- A Yes. Anytime I stayed at the motel it was either with Rossi or with Cram when they were with. I got some jobs when we went up to Wisconsin, there was four of us, alright? Rossi wanted to room with me. Cram took the room with Michael Carrerra.
- Q Did the three of you ever go out together at night?
- A Drinking, yeah. Yeah.
- Q How often?
- A Not too often.
- Q Did you go out with them individually.
- A Yeah I would say moreso. Moreso with Cram than with Rossi.
- Q So then conceivably every time you went out at night....
- A They were out, they were out a lot together by themselves without me.
- So you don't recall specifically whether they were with you when you were out and picked somebody else up and brought them

- home? Conceivably one or the other of them could have been with you on many of the occasions is that right?
- A Yeah its possible.
- Q What do you think about it? Do you think its conceivable? What's your feeling about it?
- A Moreso, moreso, there wa-, there was more times that the two of them went out together. See now, keep in mind Rossi and Cram were not only the only two that went out of town with me. P. E. Systems would sometimes send me out of town either alone or with one of P. E.'s representatives...
- Q P. E.?
- A P. E. Systems, their employees.
- Q Both Cram and Rossi had keys to your house?
- A Right.
- Q And they had access to it when you were gone.
- A Conceivably they could have brought somebody back there themselves.
- You found people's property in your house when you returned from....
- A Yeah, because you see, here, my neighbor across the street and my neighbor next door would, would tell me that well there was cars in your driveway while you were gone or this was going on while you were gone.
- Q What neighbors?
- A Greksa on the one side, and, of course, Smith I never talked to too much cause she was always bitchin' about people coming and going and peeling out of the driveway and shit like that. And the guy across the street. So, ya, ya know, ya know the only thing that I, I do that could, ya know, wi-with drug dealing, Cr-Cram was the big drug dealer, ya know, he had all kinds of connections for anything and everything. And...I said, "well what happens if they fuck over ya?", he says they'd just take care of 'em. They have their own way of taking care of people who fuck over 'em on drug deals.
- Q All of this time then they knew something was going on either from you telling them, or them participating?
- A I would say so, yeah.
