You are eligible to take the divisions of the computer-based Architect Registration Examination that are listed below. You must take the examination during the period indicated below for each division. To make an appointment, please call the Prometric Candidate Service Call Center (CSCC) at 1-800-479-6215. You will be asked for the Candidate Identification Number printed at the top of this form.

Please note, if you pay for the appointment with a credit card **you will be charged at the time you schedule** your appointment. You must pay for the appointment when you call using a credit card. If you wish to pay by check or money order, you must purchase a voucher from the Chauncey Group by using the voucher request form in the *ARE Guidelines*. **Please note: all payments are non-refundable. Regardless of your method of payment, it will remain valid one year from the first date you contact Prometric and schedule an appointment for each test.**

For each division listed below, write your appointment confirmation number (needed if you later have questions or have to cancel/reschedule your appointment), and the date and time of your appointment. On the reverse side of this letter, write the address and directions to the test center, and the Prometric representative's name.

On the day of your examination, you must arrive at the test center thirty minutes before your scheduled appointment to complete the admission procedures required before testing begins. Please bring this form with you to the test center. To be admitted to the examination, you must bring one form of valid identification (your ID must have a recent photograph and your signature). Please refer to page 16 of the ARE Guidelines for more specific identification requirements. The name on the photo identification must match the name that appears on this *Authorization to Test*. If the name on this *Authorization to Test* does not match your name on the signed photo identification that you will be using at the test center, please contact the board of architecture where you applied for registration.

If you do not show up or fail to reschedule your ARE appointment by **12 noon EST of the third business day** prior to your scheduled appointment, you will forfeit your testing fee and will be required to pay another testing fee in order to test. If the valid period for a division has expired, you must contact your board of architecture. Upon approval from the board of architecture a new *Authorization to Test* will be sent to you.


Dear Architecture Graduate:


