PRIVACY POLICY

Resurrection Brands LLC ("we," "us," or "our") cares about your privacy and wants you to understand how we collect, use, protect and share your personal information. This Privacy Policy explains our privacy practices in connection with information that we collect or you provide through our websites that link to this Privacy Policy (the "Sites"). By using our Sites, you accept this Privacy Policy and consent to our collection, storage, use, and sharing of your personal information as described here.

Information We May Collect

We may collect the following categories of personal information from you:

- Identification Information: First and last name, home or other physical address (including billing
 and shipping addresses), telephone number, email address, age or birth date, Social Security
 number (for sweepstakes or contest winners), account username and password, social media
 identifier, and other similar identifiers.
- Financial Information: Credit card number, debit card number, and security code.
- Commercial Information: Records of products or services purchased, obtained, or considered, and other purchasing histories or tendencies.
- Online Activity Information: Device identifiers, cookies, beacons, pixel tags, mobile ad identifiers
 and similar technology, other forms of persistent or probabilistic identifiers, Internet Protocol

How We May Collect Your Personal Information

We may collect your personal information from the following sources:

How We May Use Your Personal Information

We may use the collected personal information for the following purposes:

- To respond to your inquiries, fulfill your requests, or fulfill your product orders.
- To send administrative information to you, such as changes to our terms, conditions, and policies, as well as marketing communications that we believe may be of interest.
- To personalize your experience with the Sites by presenting products and offers tailored to you and to facilitate social sharing functionality.
- To allow you to participate in sweepstakes, contests, surveys, and similar promotions and to
 administer these activities, including in connection with tax forms for prizes. Some of these
 activities may have additional rules containing information about how we use and disclose your
 personal information. Please read those rules carefully.
- For our business purposes, such as data analysis, audits, fraud monitoring and prevention, developing new products, improving or modifying our Sites, identifying usage trends, determining the effectiveness of promotional campaigns, and operating and expanding business activities, and similar purposes.

How We May Share Your Personal Information

We may share your personal information with third parties in the following circumstances:

- To our third-party service providers who provide services such as website hosting, data analysis, payment processing, order fulfillment, information technology and related infrastructure provision, customer service, marketing, advertising, email delivery, credit card processing, auditing, and other similar services. Note: credit card/debit card information is tokenized and provided directly to service providers.

- To third-party sponsors and fulfillment vendors of sweepstakes, contests, surveys, and similar promotions you choose to enter.
- To your friends associated with your social media account, to other website users and as well as to your social media account provider, in connection with your social sharing activity. By

Collection of Other Information

We may collect other information from you that does not reveal your specific identity or does not directly relate to you as an identifiable individual, such as:

- Information Provided by You: Demographic and other information (such as your state of residence and your preferred means of communication) voluntarily provided by you.
- Aggregated Information: We may aggregate personal information and use the aggregated information to analyze the effectiveness of our Sites, to improve and add features to our Sites, and for other similar purposes. In addition, from time to time, we may analyze the general behavior and characteristics of users of our Sites and share aggregated information like general user statistics with prospective service providers. We may collect aggregated information through the Sites, cookies, and other means described in this Privacy Policy.

Please note that we may use and share such other information for any purpose.

Data Security

We use reasonable organizational, technical, and administrative measures designed to protect personal information within our organization from unauthorized access, use, or disclosure. Do Not Track

We do not track your online activities over time and across third-party websites or online services and therefore do not respond to "do not track" ("DNT") signals. Third parties cannot collect any personal information from our Sites about your online activities unless you provide it to them directly.

Choices and Access

No Use of Sites by People Under the Legal Drinking Age

California Residents

- Right to Know: You have a right to request, up to twice in a 12-month period and free of charge, that we disclose to you: (a) what categories and specific pieces of personal information we have collected about you; (b) the categories of sources from which personal information are collected; (c) our business or commercial purpose for collecting, using, or disclosing personal information; (d) the categories of third parties with whom we share personal information; and (e) the categories of personal information we have sold or disclosed to third parties for a business purpose.
- Right to Opt-Out: You can request that we not sell or share your personal information

 share your information in exchange for monetary compensation. Certain sharing of your
 information, however, may be considered a "sale" under the CCPA's broad definition.
 In particular, in the last 12 months, if you have visited the Sites, we may have shared your

identification information or online activity information with advertising service providers and social media platforms to match and serve our targeted advertisements on third-party websites.

- Right to Delete: You can request that we delete personal information we collected from you and tell our service providers or contractors to do the same, subject to certain exceptions (such as if we are legally required to keep the information).

Colorado, Connecticut, Nevada, or Virginia Residents

If you are a resident of Colorado, Connecticut, Nevada, or Virginia, you have the right to request that we not sell your personal information to third parties. We do not sell, exchange, transfer, or disclose personal information to third parties in exchange for monetary or other valuable compensation.

Verifying Requests

To help protect your privacy and maintain security, we will take steps to verify your identity before granting you access to your personal information or complying with your request.
